Special Commission of Inquiry into LGBTIQ hate crimes – Production of documents pursuant to Summons No. NSWPF85

We refer to summons No. NSWPF85, issued to the Commissioner of NSW Police (**Commissioner**) on 13 April 2023 (**Summons**), with a return date of 24 April 2023. A copy of the Summons is **enclosed** with this letter.

I am instructed that no documents responsive to the Summons are held by NSWPF. To assist the Inquiry, I set out the following information that has been provided to me to explain why no documents have been able to be located:

- a) On Friday 14 April 2023, enquiries were made with Ms Amber Stroud, Manager of Information Services Strategic Intelligence & Capability Command. This is the current equivalent of the 'Crime Data Centre'.
- b) Ms Stroud confirmed there are **no** digital records held by NSW Police (**NSWPF**) from Plain Clothes Constable Morige in respect of the request made on 8 July 1995.
- c) Ms Stroud considered that if a record does exist, it is most likely to be held in the archived material subject to the specific investigation into the death of Mr James Meek in 1995. That archive material was provided to the Inquiry in response to Summons 2 on 2 June 2022. A list of the material provided to the Inquiry is set out in Annexure A to this letter.
- d) Further, Ms Stroud advised that as of 2002 NSWPF implemented the 'iAsk' system which is an interface where police can make a request for information from telecommunication companies and the results are retained. The information available in the iAsk system is limited to the extent that all telecommunication companies retain data/material for seven years.
- e) A search of the iAsk system shows Plain Clothes Constable Morige did not make any requests in respect of the phone number the subject of the request made on 8 July 1995.

I am instructed the above searches and enquiries to be an exhaustive search for the material requested by Plain Clothes Senior Constable Morige and no further avenues of enquiry are available to NSWPF to locate the material.
