- 1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated in it anything which I know to be false or do not believe to be true.
- 2. My age is 42 years.
- 3. I currently work as a part time attendant at the Kingsteam Sauna, situated at Oxford Street, Darlinghurst. I have been working there for about six months. My duties are to collect cash, hand out towels and locker keys and ensure patrons sign the register on the front counter area. I work on Saturday and Sunday nights only between 6pm and 1am. Originally I started work at the canteen area within the premises but for the past two months I have only worked at the front desk/counter area.
- 4. The Kingsteam sauna is a homosexual club. Patrons to the Kingsteam pay \$20 at the front counter. They are then given a locker key and a towel by myself and they sign the entry register. This register shows the locker key number for each person and their signature. After this they enter the premises where they get undressed and wear the towel provided.

- 5. Within the premises is a sauna, a steam, jacuzzi, Television lounge and a gym. There is also a canteen area where light snacks and drinks are provided at a charge. There are also cubicles where patrons can engage in sexual activities if they wish.
- 6. On Sunday 11 June, 1995 I was working at the Kingsteam Sauna, commencing at 6pm as usual. I recall on this night that we were extremely busy for the first hour and a half. In this period I would estimate that approximately 44 patrons attended the premises. During my shift I would estimate between 100 and 120 persons attended the premises. I can estimate this due to the number of pages that were used for persons entering and signing the entrance book.
- 7. On Wednesday the 21 June, 1995 I attended Kings Cross Detectives office where I spoke with Detective TAYLER. Detective TAYLER showed me a photo of a male person. I recognise this photo as being the same male person that was on television after being killed recently. I do not recall seeing this male person at Kingsteam. I do not recall ever seeing this male person before.
- 8. Detective TAYLER showed me a photo of a second male person ( NP215 ). I did not recognise this person at all.
