- 1. This statement made by me accurately sets out the evidence which I would be prepared if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated in it anything which I know to be false or do not believe to be true.
- 2. My age is 62 years of age. (32)
- 3. I have lived at the above address for the past four and a half years since I returned to Australia from Los Angeles, United States of America. I had been living in America since 1976.
- Last Saturday week the 3rd June, 1995 I was at home with a friend of mine, NP199, I don't know his last name. He is a friend who I have known for the past year and a half, who lives in the country by himself. I am a homosexual and so is NP199. During that afternoon, NP199 rang two mutual friends of his and invited them to my home. About 3pm NP199's two friends arrived at my home, we had some coffee and talked. I was introduced to the two men as NP215 and his friend Ken, I don't know what his last name is. They are both homosexuals living to-gether for the past five years. After talking for about an hour, NP215, Ken and myself decided that we wanted to have sexual contact with each other. I took NP215 and Ken into my bedroom, and NP199 waited outside, then NP215, Kean and me had some homosexual activities between the three of us, which lasted

for about an hour. Later after a short discussion NP215 and Ken left together about 5pm.

During the afternoon of the 6 June, 1995 NP215 rang me at home and we had a conversation for a short time. I also invited both him and Ken to come to my home for dinner on the next Saturday evening. A short time later NP215 again rang me and told me something. (That Ken was entertaining a male friend that night, and he, NP215 didn't want to meet this other man. He only described Kens friend as an Asian named NP196 or NP196).

As a result of our conversation, NP215 came to my home about 7.30pm that night. We watched a bit of television, and then a short time later we went to my bedroom and we had a sexual contact. He left my home about 10pm that night and he told me that he was going to his home.

- 6. Just after 6pm last Saturday night the 10th June, 1995 NP215 and Ken arrived at my home for dinner. We talked for awhile and had a few drinks of wine with dinner. Just after that the three of us went into my bedroom and the three of us had a sexual encounter between us.
- Just before 10pm Ken said, "I'm tired. I want to go home." NP215 and Ken appeared that they had an arrangement where Ken was going to go home or somewhere else, and NP215 was going to stay with me. I saw that NP215 had brought a bag with a tooth brush and shaving gear. When Ken left my home he was in good spirits and we made arrangements to have further get togethers. NP215 stayed at my home for the rest of the weekend.
- 8. About 2pm on Sunday afternoon, NP215 rang a telephone number and I heard him say, something like, "Ken. I'm okay. I love you. It's about 2pm". (NP215 told me that he had telephones his home and that nobody was at home and he had left a message on the answering machine.) I cannot remember if NP215 tried to ring Ken again or not on Sunday.
- 9. About 9.30am to-day (Monday 12 June, 1995) I had a conversation with NP215 (I said, "Don't you think you should ring Ken and tell him you are alright") I then saw NP215 dial a telephone number and he told me something. (That the answering machine was not turned on, and nobody answered the telephone). NP215 remained with me the whole

of the day, we just sat around read the newspapers until about 5pm and he left my home with the intention of going home.

- 10. About 6.10pm this evening I was at home and I received a telephone call from St. Vincents hospital. I caught a taxi to St. Vincents hospital emergency unit and I saw a nurse and she told me something. As a result I went into a room and I saw NP215 and he told me something. (NP215 said that he had returned to his home unit, and as he was walking in he saw that the lights were on and the blinds were open, which was unusual because the windows faced west. When he entered the flat he saw Ken lying on the floor with his mouth and eyes open. He said he saw blood on the floor and ceiling).
- I have only known NP215 and Ken for about ten days and I have never ever visited their unit at Elizabeth Bay. I would describe Ken as an Australian, in his fifties, either fifty three or four, about 5'8" tall, a heavy set guy, sort of fat build with brown hair, greying on the sides. From my conversations with NP215 it is apparant that Ken has many homosexual partners and likes a lot of sex with a lot of different people, and that NP215 joins in to make up threesomes. NP215 also told me that he had an arrangement with Ken, that neither, he, or Ken would take strangers or other partners to their home for sex, unless the other person was present. NP215 also told me that Ken was attracted to orientals (asians) and they had an agreement that neither Ken or NP215 would take asians to their home, because NP215 did not like asians.
