- 1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated in it anything which I know to be false or do not believe to be true.
- 2. My age is 62
- June, 1995, I mention a person by the name of NP199 I met NP199 through the Capital Q magazine. I had placed an add, this was the one and only advertisement that I placed 1993, about August-September. NP199 had replied to my advertisement by talking to the 0055 telephone number and I contacted him. I have been in contact with him for the past 2 years. I do not know his surname or his address. I have the telephone number at home and I think he comes from a small country town above Newcastle somewhere.
- 4. In paragraph 6 I mentioned that we drank white burgundy. Ken and NP215 had bought a bottle of the same wine but of a different brand.
- 5. In paragraph 7 I mention Ken leaving the unit on the Saturday night sometime after 10.00pm. When Ken left the unit he did not indicate to me or NP215 what his plans were for the

rest of the long weekend. He mention that he was tired, was going home and going to bed.

- 6. On the Sunday NP215 and I did not go outside the door of the unit. I got out of bed at about 9.00am. My mother called at about 8.30am, I did not get to the phone in time to answer the call and the answering machine took over and I heard her voice out aloud. My mothers name is 1274 and she lives at Miranda, telephone no.
- 7. During the day my sister 1275 also telephoned the unit and I spoke to her about going to the movies to see 'Priest'. 1275 lives at Sutherland, and the telephone number is
- 8. Peter PASCOE also telephoned the unit and asked me to collect the newspaper for him on the Monday. I usually get the Sydney Morning Herald and we read the pink TV guide for the week together. It is most likely that he called and asked me to come around.
- 9. On the Sunday evening NP215 and I watched a movie, Apartment Zero, on a video disc. This disc was bought by me in the United States and forms part of my movie collection. NP215 and I went to bed at about 11 or 12 o'clock. We awoke in the morning, Monday, at about 9.00am. I recall NP215 making a telephone call at about 9.30am to his unit. I did not hear NP215 talking on the telephone. NP215 made another telephone call again about half an hour later. Again this time I did not hear NP215 speaking into the telephone. NP215 mentioned that it was unusual that there was no answer and NP215 suggested that he may have gone out for the papers and not turned the answering machine on. After the second call NP215 mentioned that Ken may have been going to the Blue Mountains to visit some friends up

there. My friend Peter PASCOE telephoned again about 10.45-11.00am, NP215 and I left the unit and went to the deli in Ocean Street, they had run out of newspapers. We then walked around into Queen Street to the newsagents, they were closed. Then we went to the BP Service Station on Edgecliff Road, this is just below the Junction. I bought Two Heralds there. I had a coupon on the back of a Franklins receipt, which was a deal 2 Big Macks for the price of one. So we then walked to the McDonalds at Bondi Junction, just up the road from the BP and I bought the 2 Big Macs for \$2.50. We sat down in McDonalds and ate the hamburgers. We then walked to Peter PASOCES home in Edgecliff Road. I gave Peter the paper, sat and talked for maybe 10 minutes and then left. We then walked back to my unit, and arrived back at about mid-day.

- 10. Also on the Sunday I received a telephone call from Peter SULLIVAN who rents a room in 1282 home at Petersham. Peter rang to arrange to come over on the Monday night, this arrangement was confirmed with Peter SULLIVAN that he would come over on the Monday evening about 7.30pm. I also asked him about his studying and how it was going and there was also mention by Peter about my packing. I am currently packing my property up in preparation of my move to Newport.
- 11. NP215 and I remained in the unit that afternoon, until about 5.00pm when NP215 left to go home. No one had telephoned or visited the unit during this time.
