- 1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated anything which I know to be false or do not believe to be true.
- 2. I am 39 ( 56) years of age.
- 3. I have lived in the area all my life and have been living in for the past seven years. I live there on my own and have my kids on the weekend. I have a boy and a girl from my marriage. I was married and the marriage lasted seven years. I have been working for and have been employed with that company for the past 21 years. I am a homosexual and have been for the last eight months.
- 4. I am a member of Country Network and this is a program where you are able to meet people when you are travelling throughout Australia. I have been a member for about 6 months and I have registered my name and address with the company.
- 5. In the beginning of May last year, Ken contacted me by

phone through a friend in the Network, 1282. 1282 had told Ken to stay at my place. I invited Ken to stay as he was doing a teaching job in the Griffith area. He arrived on a Thursday I don't know the exact date. He arrived at 6.00pm in the evening, we talked for a while, had sex and then had dinner. Ken was a bit pushy and made the first moves. He slept with me for the night, we had more sex during the night and he left at about 7.00am the next morning. He had arrived by hire car the night before and left in his hire car.

- 6. During the time I was with Ken he spoke about his partner NP215 and how they had an open relationship. Although it was only on Kens side, NP215 wanted a closer relationship, like being married. Ken was very sexually active for his age, not forceful at that stage.
- 7. The next night when I was at home on the Friday, I got a phone call from I think it was NP215 and I a little bit guilty, I was surpirsed that he had rung. He said that Ken had said he enjoyed staying at my place and said that if I was coming to Sydney that I would have to stay at their place. I had a conversation with NP215 of a sexual nature and we spoke about what they (Ken/NP215) wanted me to do when I was at there place. They were interested in having a threesome with me, but I am not into that time of thing. I just usually have one partner. The conversation on the phone lasted for about 1 hour.
- 8. Between that time and when I came to Sydney I probably spoke to both Ken and NP215 on the phone about times. I have rung them on occasions and they have rung me. I have not seen them at all since seeing Ken.

- had arranged a holiday from work, I took two weeks holiday and decided to come to Sydney. Before I came to Sydney I several men from the network, to make arrangements to stay were all right. I had made arrangements months before. I cant remember who I contacted. I arrived on the 31 May, 1995, which was a Wednesday and Wayne picked me up from the airport I went and stayed with Wayne at Mortdale.I can; t remember his exact address. I stayed with Thursday and Friday and on Saturday morning the 3 June, 1995, took at Stanmore. I was supposed to stay with him me to David for two nights, but he scared me a lot. So I rang 1282 and 1283 and asked them to pick me up the next day. David was into strange things, he was into whips and bondage and I wasnt attracted to him. I did'nt have sexual contact with him and I just wanted to get out his place.
- 10. | 1282 | and | 1283 | came and picked me up about 1.00pm the Sunday the 4 June, 1995. They drove me around Sydney and showed me some places. We visited a friend in hospital. Then they took me to another guys place at North Parramatta, his name was Barry got on well with him and we had sexual contact. I stayed with him Monday the 5 June and I left on Wednesday the 7th. phoned up and 1301 to see if I was on my way and what was going on. I was with 1301 at the window and Ken phoned up and said where is NP189 NP215 has been waiting down stairs at their apartment for 20 minutes. So 1301 walked with around to NP215 and Kens place with me. We walked to the front entrance and 1301 spoke to Ken on the intercom. The door opened 1301 left and I went up the elevator and got out on the fifth floor. Ken met me in the hallway. Ken wearing black trousers and a white shirt. We went into the unit, NP215 showed up a little bit later and I met NP215 It was about 5.30pm when I met NP215 The three of us had a drink, Ken and I had a bottle of wine and NP215 had a can of Southern and coke. We talked for a while, Ken was cooking tea and said that we all had to take our clothes and have tea in the nude.

- 14. So we all clothes off, Ken had made some sweet and sour chicken and rice and we all sat and ate it in the nude. Ken and I kept drinking wine through dinner. The main topic at dinner was sex. Ken made a lot of suggestive remarks about wanting to screw me and would'nt take no for an answer and about the three of us sleeping in the same bed for the night. NP215 wasnt happy about ken making moves on me, not because of their relationship but because he could see I was getting pissed of about it. I did'nt really want to have sex with Ken.
- 15. I was not drunk at this time, neither was Ken or NP215 we went into the bedroom. I found that I related to NP215 better, and became obvious to Ken that I was not interested in him. I had a bit of oral sex with NP215 and Ken was trying to join in. Not much else had happened at that stage, Ken got out of bed and went into the kitchen to do deserts and me and NP215 stayed in

bed and as soon as Ken left I felt a lot more relaxed with just one person. Then Ken got annoyed because he said, deserts were ready and we were still in bed. So we got up out of bed and all sat at the table and had desert in the nude. Then the phone rang and it was some guy they knew, I think they have sex with him every now and again and they were telling him to come down while I was here. Ken said to the guy if you come down to see NP189 we will disappear for a while. But then he wanted to change it to a foursome and I think that is what was on his mind from the start. The arrangements on the phone by Ken were made for the Tuesday night (13 June, 1995.)

I think then Ken rang another named NP214 Ken spoke first and then NP215 stayed and talked to him in the bedroom on his own. Then when NP215 came out of the bedroom I could see he was upset. I don't know what it was but he started bashing plates around and then him and Ken had a domestic over who does all the chores in the house. Then everything calmed down and we were going to bed for the night. The three of us got into bed, I was in the middle we were still all naked. I had told Ken that I was'nt interested in sex and that I was prepared to sleep in the floor on the lounge room and he said I couldnt do that because they did'nt have any blankets for me. When we were in bed I faced NP215 s side and I was cuddling him and everything sort of started from then, Ken waited till NP215 and I got a bit excited and then he joined in, we all had oral with one another. I would kiss NP215 but I would'nt kiss Ken or touch him that much. Ken was always going on about anal sex all the time. He then done it to NP215. I then had anal with Ken, I mean I did it to him. I hated it I just wanted to stop. I did not ejaculate this time.

- 16. I sort of think of Ken as pain because he gets of giving pain to people, like he would grab and squeeze your nipples, I had to tell him to not grab me because he was so sore. Even was so sore. Even was pain because he was so sore. Even was not all that interested and it just sort of stopped, I don; t know whether they came or not. We just rolled in to sleeping position and I just cuddled up to NP215 Ken rolled over to me and touched me and I wasnt very nice and shrugged him of a bit. The next thing he got up and went and slept on the floor in the lounge room.
- 17. The next morning about 6.30am Ken got up and he was getting ready to go to work. He went and had a shower, he came out and was getting dressed in the lounge room kitchen area, NP215 and myself we started touching one another again. NP215 started doing oral to me, Ken walked back in, he said something like "Oh good" he pulled his jocks down and started playing with himself, and then he reached over and started touching me and NP215 then i think he realised I was not interested and he made a nasty comment to me that he was annoyed and walked into the lounge room, got dressed and went. I didnt see what he was wearing.
- 18. NP215 and I just touched after that for a while, and NP215 said we better get ready to go, and he told me that I could stay. I was to come back that night NP215 had got a set of keys cut for me. He got them before I came, some of the keys were cut with that different coloured stuff, the main one for the door I think that was an original one. NP215 gave me the set of keys. There was at least four keys on a key ring with something on it I cant remember it really. NP215 told me I could stay but I told him that I wanted to go to 1301 s.

- 19. I phoned [1301] up between 7.30am and 8.00pm. to tell him that I was going back to stay at his place. Then [NP215] and I left the unit, [NP215] was going to Kings Cross station, and we walked dow to opposite [1301] s place near the station, had a kiss wand he went to the station. I went to [1301] s place buzzed the buzzer I went in and went to his unit number [1301] met me at the door. I told [1301] about the horrible night I had had. I told him the whole story about the other bloke coming and I did'nt want to be involved in it. Like if I don't like a threesome I would'nt like a foursome. I also told him about the friction between [NP215] and Ken and how Ken told me earlier that he think he wanted Ken and [NP215] to go there separate ways. I told [1301]; all about this and about how I feel uncomfortable and he told me that the best thing would be not to go back.

Then that day [301] and I went around the city, [301] went to the Westpac bank in Oxford Street, then he paid the electricity bill at the head office, then in the afternoon we went to Sydney University for a swim, then we were coming home and we got to Kings Cross Station, [301] thought some bloke was eyeing him off, so he said to me that he was going to walk of on his own and see what happens, so I went down the escalator and
