time at college, on one occasion I was late for school and a teacher by the name of George told me to pack my gear and return the next day.

- 6. That day I caught a bus to Sydney and went to the Surry Hills area and stayed three or four nights at the Oasis and gave the name and told them I was 17 years old. During this time I rang up 1291 and asked him if my apprenticeship was still open. He told me it was open. At the time I was using drugs and alcohol, met up with some friends and we decided to go up to Cairns. I was in Sydney for about one month.
- 7. I hitch hiked up to Cairns with two of my friends and it took about two or three days to get there. In Cairns we stayed at Rusties Hotel paying about \$13.00 a night for accommodation. We also stayed in squats and on the street.
- 8. I ended up spending two months at Lotus Glen Prison for assaults and other matters. From there my brother, paid for my airfare to return to Melbourne. I did not end up taking the flight because the New South Wales Police extradited me from Lotus Glen Prison to Sydney to go to court on 1992 matters.
- 9. I have been shown the FACE image No. F A00563 of a male, I do not think that I look like this person.
- 10. I have been shown a large colour photograph of a male person with a moustache who I have told his name is Kenneth BRENNAN.
- 11. I have never seen this man before and do not know him. I
