1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated anything which I know to be false or do not believe to be true.

2. I am 31 years of age.

3. I have been residing at [REDACTED] Annandale for the past week. Prior to that I was living at [REDACTED] Lilyfield, with my parents and other members of my family. This was on a casual basis for the past 3 years. During this time I have also lived at [REDACTED], BLACKTOWN with [REDACTED] 1288 and my son [REDACTED] who is [REDACTED] years old. I have also lived at [REDACTED], Blacktown, with a friend [REDACTED] and his family.

4. I have another son, [REDACTED], who is [REDACTED] years old to [REDACTED] [REDACTED] and [REDACTED] live at [REDACTED] Lilyfield. [REDACTED] works as a [REDACTED] at the [REDACTED] in Balmain. For the past six years I have had an arrangement with [REDACTED] that I look after [REDACTED] most weekends. Most of these weekends I would take [REDACTED] to my parents place in [REDACTED], Lilyfield where I would look

5. I have been recently working for my brother-in-law, [REDACTED], of [REDACTED] Petersham as a labourer. I have been working for him on and off for the past 3 to 4 months. Prior to his work I was unemployed.

6. I am pretty sure that during the month of June, 1995, I was living with [REDACTED] 1288 at her Blacktown home. On most weekends at Blacktown I would spend time at the unit watching television. Occasionally I would visit Video Ezy video store in the main street of Blacktown to hire a movie using [REDACTED] 1288's video card. Other times I might go out for the day with [REDACTED] 1288 and [REDACTED]. I am unable to tell you where I was on 11 June, 1995.

7. I have an account with the St. George Bank with has a Automatic Teller Machine card. This account, St George Freedom Account, was opened at the Merrylands Branch in about 1986 in my name, [REDACTED] NP202 of [REDACTED] Lilyfield. I would often access ATM machines to withdraw cash.

8. I have been in receipt of Social Security benefits for the past 7-8 months. This money is deposited into my St George Bank account. I have no other bank accounts.

9. I am unable to say when I last visited the Kings Cross area. At times, whilst living in the Blacktown area, I would go into the city with friends and we might drive down the main street of Kings Cross to have a look. Unless we needed petrol or food we would not stop in the Kings Cross area for any reason. I am able to estimate that maybe in the last 6 months I
