- 1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated anything which I know to be false or do not believe to be true.
- 2. I am 24 years of age.
- 3. I reside at Lawson, with my mother. The telephone number at this address is
- 4. Approximately one to two months ago I purcharsed a copy of the gay newspaper, Capital Q. I purused the personal columns in this newspaper and found an advertisement which was something like, 'Two guys interested in finding another guy, for fun times', a code number was attached to this advertisement.
- 5. From my home I telephoned the 0055 number in response to the advertisement and quoted the code number for this particular advertisement. I was then connected to a voice mailbox and I left a message similar to, 'My name is NP184, if you want to call me, ring me on or '.
- 6. About one week later whilst I was at home I received a

telephone call from a male who identified himself as Ken. He told me that he was ringing about the add and asked me if I wanted to meet him at his place. I agreed to meet him on the following Saturday or Sunday morning at about 11.00am or 12.00am. Ken gave me his address at which is the name of the flats, I don't recall the flat number, and he also gave me his telephone number. Ken suggested that I meet him at Kings Cross, near the fountain, and he would then take me to his unit. I described myself for Ken so that he would be able to identify me.

- 7. On Saturday, 3 June, 1995, left my home at Lawson and travelled by train to Kings Cross, arriving about 1.00pm. I then walked to the fountain where I waited for about 10 or 15 minutes. I then telephoned the number that Ken had given to me during the telephone conversation and I spoke to a male who identified himself as NP215 [NP215] told me that Ken had just left. A short time later a male approached me and introduced himself as Ken. I then walked with Ken to his unit, I remember walking down a small laneway to a 5 or 6 storey block of unit, the units had a security door.
- 8. At the unit I met another male by the name of NP215. I stayed at the unit for about 2 to 3 hours and during this time I had sexual intercourse with Ken. NP215 also participated in this threesome. During the threesome Ken was the more dominant person who would ask both myself and NP215 to perform certain things. No other person was present during the time that I was at the unit.
- 9. When I came to leave, Ken mentioned that they were both going away in about two weeks time. He asked me to call them

back after they had been away to possibly get together again. I then left the unit and met up with another friend in the Kings Cross Area. I left by train from Kings Cross about 4.00pm and travelled back to Lawson.

- 10. I never telephoned Ken or NP215 at there unit after this visit. I did not like the idea of a threesome.
- 11. On the Monday after seeing Ken and NP215 I received a message from a workmate that a person by the name of NP215 was on the telephone and wanted to speak to me. I told this workmate that I did not wish to speak to him. I believe the call was then terminated.
- 12. I would describe Ken as being in his early 40's, brown hair, wore glasses, chubby build, Australian, abut 5'8" tall. I would describe NP215 as being in his early 30's, black straight hair, wore glasses, skinny build, Australian, and a bit taller than Ken about 5'11" tall.
- 13. On Saturday the 10th and Sunday the 11th of June, 1995, I spent with my friend Jeff ROGERS at his home in Kogarah. About mid-day on Monday, 12 June, 1995, I travelled back to my home at Lawson.
