3. About two months ago I responded to an advertisement in the Capital Q magazine. I really cannot recall what the advertisement stated but I do recall that it was for three people. As a result I phoned the voice mail box that is in the advertisement and I left a message and my mobile contact number.

4. I cannot recall what my message was, I think it would have been to the effect of being interested in the advertisement and for them to ring me back.

5. At this time there were two advertisements that I responded to, both were from the Capital Q magazine. I never heard back from either of the advertisers.

6. On Thursday the 6 July, 1995 I attended Kings Cross Detectives office where I spoke with Detective TAYLER. Detective TAYLER showed me a photograph of a male person that had been killed in Elizabeth Bay. I have never seen this male person before.

7. At 9pm on Saturday the 10 June, 1995 I was working night shift. I am self employed as a surveyor and I am currently contracted to [REDACTED], at Mascot Airport. Due to the flight curfew the contract must be fulfilled in the evenings during curfew hours. This involves myself starting work at 9pm and finishing around 4am. I have an employee who worked with me at this time named Anthony HENDERSON, Ph; [REDACTED].

8. After finishing work on the Sunday morning the 11 June, 1995 I went to a friends house, Margaret ROBINSON at [REDACTED] [REDACTED] Waverton, Ph; [REDACTED]. I would have arrived at Margarets house about 4.30am. I remained with Margaret for the rest of the day. I think that we may have gone to lunch later that day, but I cannot be sure.

9. I remained at Margarets house until about 8pm on the Sunday evening, I then returned to my residence before attending work at 9pm. I then again worked with Anthony HENDERSON until about 4am on the Monday morning.

10. After work on the Monday morning I returned to my residence where I slept and then about 9am I went to Margarets house. We then left for Noosa at 11.25am on Ansett flight [REDACTED].

11. I have previously attended the Kingsteam Sauna in Oxford Street, Sydney. I have been there on two occasions, the last time being during 1994.
