1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated in it anything which I know to be false or do not believe to be true.

2. My age is 52 years.

3. I have been residing at the above address since January, 1995. I reside their alone and rent the premises through Raine and Horne, Bondi Junction.

4. Within the last two months I responded to an advertisement in either the Capital Q or Star Observer magazine. The advertisement basically stated that two people wanted to meet one person for possible sexual activities. I responded by phone and left my details including name and telephone number on a 0055 mailbox number.

5. About a week after I responded to the advertisement I received a phone call from a male person. I do not know this male persons name. The male informed me that he lived in Elizabeth Bay and that two people were involved in the advertisement. I think he told me his age which I think was in the 40's. I cannot recall any further conversation but I think I ended the conversation by telling him I was interested in somebody younger.

6. The call was terminated and I am fairly sure I did not

obtain this persons telephone number.

7. On the Queens Birthday long weekend I remained in Sydney. About 1pm on Sunday the 11 June ,1995 I attended The New South Wales Bridge Association in Goulburn Street, Surry Hills. I remained there playing cards until about 5pm. I believe that I then walked home which would have meant I arrived home about 5.30pm to 5.45pm.

8. I then remained home alone until about 7pm that night when I went out for dinner. I remember having dinner with two friends of mine and their 10 month old child. I cannot recall exactly where we went to, but I believe it was either in Victoria Street, Darlinghurst or in the East Sydney area. I do not wish to provide their names at this stage until I speak to them about this first. Basically I do not wish these people to be involved in a murder case without being satisfied their is a compelling reason. After I speak with these persons, I will contact Detective TAYLER and provide him with their details if I feel there is no problem.

9. I remained at dinner and arrived home about 10pm. I returned home alone, where I remained for the rest of the evening until Monday the 12 June, 1995. I believe I stayed at home until about 11am on the Monday morning.

10. On Saturday the 24 June, 1995 I spoke with Detective TAYLER at my residence and then shortly afterwards I attended Kings Cross Detectives office. There Detective TAYLER showed me a photo of a male person. (BRENNAN) I have never seen this male person before. I have never attended Kingsteam Sauna in Oxford Street, Sydney or other similar homosexual clubs.

11. Detective TAYLER informed that this male person had placed the advertisement that I had responded to. He also informed me that this male had been killed over the long weekend. I had not heard of this incident until this date when informed by Police.

12. Apart from the one telephone conversation after I replied to the advertisement, I have had no other contact regarding the advertisement.
