STATES:-

1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated anything which I know to be false or do not believe to be true.

2. I am 28 years of age.

3. I reside at [REDACTED] Darlinghurst, with my boyfriend Stuart [REDACTED]. I am the owner of a mobile telephone No. [REDACTED] which I have owned since May, 1994. The telephone number has not changed from its present number during this period.

4. About one month ago I purchased a newspaper, Capital Q, which is a Gay and Lesbian community newspaper. I perused the personal columns of the newspaper and recall one particular add which was similar to, 'Elizabeth Bay, two well hung guys seek third for fun times', I think there was mention that the men were in there late 20's, and there was a code number listed.

5. That day, or within a couple of days I telephoned the 0055 Capital Q mailbox number to respond to the advertisement. I put in the code number for the ad, there was no responding message left by the advertiser, so I then left my reply message. I recall saying something similar to 'he guys responding to your

ad give me a call back', and I left my mobile telephone number,
 [REDACTED].

6. I am unsure as to whether I responded to other advertisements in this same edition of the Capital Q newspaper. I am pretty sure that I did not receive a reply from the above advertisement.

7. Over the past few months I have placed advertisements in the personal column of the Sydney Star Observer for sexual partners. I have met about five or six people through this form of advertising. This system operates in a similar way to the 0055 system adopted by the Capital Q magazine. In the last two months I have not met any people by the name of Ken or **NP215** through the Capital Q or Sydney Star Observer newspapers.

8. I have visited Kings Steam in Oxford Street, Darlinghurst on about three occasions, this was prior to me moving into my current unit. I have been at my current address for about 2 years and two months.

9. I have frequented Kens Karate Klub or KKK at Kensington during the early part of 1995, and I would go there once a month. I have not been to KKK for about two months.

10. At this stage I am not able to state my whereabouts on the Queens Birthday Weekend, 10, 11 & 12 of June, 1995. I have a work diary at my work studio, [REDACTED] Sydney, and should be able to check my whereabouts by referring to my diary.
