Pokolbin area for dinner. I stayed at Pokolbin on the Friday evening and remained in the Pokolbin area until about 9.30am on the Saturday morning. I then drove back to Sydney alone.

6. I then performed my duties in the real estate office and about 5pm on the Saturday evening I attended a birthday party for a friend, Damien ROACH at **Example 1**, Bondi. I stayed there till about 11pm and then I returned home to Darling Point.

7. I awoke about 4.30am on Sunday the 11 June, 1995 and I again drove to the Pokolbin family residence. I arrived there about 6.45am. I then remained at Pokolbin for the rest of the day and that night. I then returned to Sydney on the Monday about 12pm.
