STATES:-

1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated anything which I know to be false or do not believe to be true.

2. I am 28 years of age.

3. On ~~Sunday~~^{Monday} the 12 June, 1995 I was rostered to perform station duty with Constable GLASSON at Kings Cross Police Station. At 5.32pm [NP215] walked into the front reception area. [NP215] appeared distressed. He out of breath and was breathing heavily.

4. I approached the reception counter. I said, " Hello how can I help you." [NP215] dropped his head and arms on the counter. He shook his head from side to side. He lifted his head and said, " My friend's been murdered there's blood everywhere, it's all over the walls it's everywhere."

[NP215] legs started to give way and [NP215] began to slide off the counter. I jumped over the counter and grabbed [NP215] his jacket. I assisted him to a chair.

5. I said, " What's the address."

[NP215] said, " [REDACTED] Onslow Avenue, Elizabeth Bay, [REDACTED]." I wrote the address on a piece of paper. I gave the address to given to Constable First Class O'REARDON and Constable FORD. I asked [NP215] the address again and wrote the address down. I gave this address to Senior Sergeant SHIELS. [NP215] repeated a number of times, " Oh God, what am I gonna do."

6. I said, " What's your name."
He said, " [NP215]" Senior Sergeant SHIELS and I assisted [NP215] to an interview room. I left the room and returned a short time later with a cup of coffee. Senior Sergeant SHIELS and [NP215] were seated Sergeant SHIELS was asking [NP215] a number of questions and I saw Sergeant SHIELS write on a piece of paper. [NP215] said, " I went into the bedroom. The blind was up it's never up in the bedroom." [NP215] mentioned the he thought Ken was watching television. [NP215] mentioned something in relation to the answering machine not being connected to the telephone and how he thought Ken had just gone out for a walk. He also stated that the door was dead locked and when he left the unit he locked the door behind him.

7. A short time later Sergeant SHIELS left the room. I stayed with [NP215]. He said, " Oh god, how am I gonna tell his parents." [NP215] appeared distressed, he was shaking and unable to sit in his chair without moving around. I asked [NP215] [NP215] if he was cold and to put on his jacket. He stated he was hot.

8. Sergeant SHIELS entered the room and told me to organise an ambulance. I dialled triple 0. While waiting I attempted to console [NP215] who had lent forward with his head on his

knees and was making a crying sound. He said, " The blood there was so much blood I keep seeing it in my head." I placed my hand on [NP215] back and rubbed it. He said, " There was so much blood and then I saw him there his eyes there open and staring up."

9. I said, " Was he your boyfriend?"

[NP215] said, " Yes, were've been together for five years. We lived their for two." I tried to console [NP215]. He said, " You know we've had problems like anyone and when we went out and I rang and he said stay there and enjoy yourself." [NP215] mentioned that he had telephoned Ken on one occasion and he got the answering machine and he rang the next day and the phone rang out. He also mentioned that at the time he entered the unit he was carrying a black bag over his shoulder. When he saw the blood and then he saw Ken and threw the bag onto the floor. But he never touched anything.

10. The detectives arrived and [NP215] repeated that he never touched anything. I asked him to explain about the bag. He told the detectives that he threw it. I asked if he had anyone he wanted me to contact. I wrote down some addresses from [NP215] [NP215]. One was for his friend [NP214], [1282] I required as to any family Ken might have. He stated Ken's wife Rosemary FERGERSON who he is separated from, his mother and, his sister Rondah SALER.

11. Two ambulance officers arrived and a short time later left with [NP215].
