On 24 August, 1995, Detectives Thurtell, Muldoon, Best and Gordon went to [REDACTED], Hilldale in the company of Senior Constable Gary O'DWYER from East Gresford Patrol.

[NP199] was hesitant about allowing Police to enter his property. THURTELL and MULDOON entered the property and obtained a three page statement which he refused to sign without consulting his solicitor.

[NP199] stated that he was 62 years old and had been living at his present address for about 6 weeks. Prior to this he was residing at a property in [REDACTED] Broke.

Stated about 2 years ago met two males by the name of [NP215] and Ken through an advertisement in the Sydney Star and Capital Q newspapers. At the time he was living at Carrington, near Newcastle. Invited by Ken and [NP215] to visit them in Elizabeth Bay. Went to the unit and stayed overnight.

About one month to five weeks later again went to unit and saw Ken on his own. Ken stated that he would not have sex without [NP215] present.

About three months prior to 24 August, 1995, again went to Sydney and met [NP214] in his unit in Sydney. Stated he had met [NP214] through an advertisement. Telephoned Ken and [NP215] and invited them to [NP214]'s unit and introduced them to [NP214]. Ken and [NP215] arrived mid-afternoon.

Noticed [NP215]'s hair was a different colour and a different style and Ken was dressed differently. Ken, [NP215] and [NP214] then went into the bedroom and he waited outside. Ken and [NP215] left the unit about 6.30-7.30pm. [NP199] left about one hour later.

[NP199] used the names [NP199] and [NP199] when dealing with [NP214], [NP215] and Ken BRENNAN.
