OF THE LIVING ROOM. AT THE TIME THE BODY WAS  
COVERED WITH BLOOD, APPARENTLY CAUSED BY STAB  
WOUNDS TO THE BODY. BLOOD WAS ALSO SCATTERED  
ABOUT ALL ROOMS OF THE UNIT AND A BLOOD STAINED  
KNIFE WAS LOCATED ON THE BEDROOM FLOOR. NP215  
IMMEDIATELY ATTENDED THE KINGS CROSS POLICE  
STATION WHERE HE REPORTED THE DEATH TO POLICE.  
NP215 LAST SAW THE DECEASED AT WOOLLAHRA ABOUT  
10PM ON SATURDAY THE 10 JUNE, 1995 WHEN HE LEFT  
THE HOME OF A FRIEND TO TRAVEL HOME. NP215 HAD  
BEEN LIVING IN A HOMOSEXUAL RELATIONSHIP WITH THE  
DECEASED FOR THE PAST FIVE YEARS AND HAD BEEN  
LIVING AT THE PRESENT LOCATION FOR THE PAST 2  
YEARS. NP215 STATED THAT THE DECEASED WAS  
PROMISCUOUS AND HAD A NUMBER OF SEXUAL PARTNERS.  
EXAMINATION OF THE SCENE SUGGESTS THAT SEXUAL  
INTERCOURSE HAD OCCURRED PRIOR TO THE MURDER,  
WITH THREE USED CONDOMS LOCATED IN THE TOILET  
BOWL. IT ALSO APPEARED TO INVESTIGATORS THAT AN  
EFFORT WAS MADE TO CLEAN THE PREMISES AND THE  
DECEASED.
