#### 1. BRIEF OVERVIEW OF THE STRIKE FORCE INVESTIGATION

(include background, details of offences committed, suspected targets and/or organisations involved and the outcome)

On 10th June, 1995, Kenneth Richard BRENNAN was murdered in his Elizabeth Bay home unit by persons unknown. BRENNAN was a homosexual who had frequent sexual encounters with males he met in steam baths and on the street. At the murder scene BRENNAN was found naked and in the bedroom sexual aids and used condoms were found.

In September, 1996 an inquest was held at the Glebe Coroners Court in which an open finding was delivered by Deputy Coroner Mr Abernathy. Mr Abernathy recommended a reward be posted. In March, 1997 a \$100,000 reward was offered by the Police Minister.

On 18.3.97 an anonymous male contacted and gave information regarding a suspect by the name of NP200 born born.

4. RELITIMONO
With the information given in the caller was a 1302
On 6.3.98 1302 was interviewed, nominating NP200 as a possible suspect for the murder of BRENNAN. 1302 had been in a homosexual relationship with NP200 and had been stabbed by NP200 in an argument in 1996 at his home.  1302 later withdrew the charges.
The nominated suspect, NP200 leads a transient life style and was difficult to locate, until he became an inmate at Junee Correctional Centre. On 11.3.99 NP200 was interview at Junee Police Station. During the interview NP200 assisted police in questioning, during which he denied any knowledge of BRENNAN or the murder.
NP200 agreed to supply police with a sample of blood, hair and saliva. These exhibits were conveyed to Lidcombe Laboratories on 12.3.99.
On 10.9.99 Michelle Franco of the Institute of clinical Pathology and Medical Research filed a report following her DNA analysis of samples supplied by the suspect NP200 NP200 with a pair of underpants found in the main bedroom of the deceased's flat.
DNA testing on an area of the underpants waistband established that the DNA originated from more than one individual. Both NP200 and the deceased, Kenneth BRENNAN are excluded as contributing DNA to this mixture.
All current lines of inquires into the death of Kenneth BRENNAN have been finalised, with no other suspects being identified.
