As detailed in IN-20 on 17/06/2016 the following exhibits were conveyed to Sydney Crime Sydney from MEPC by DSC CLANCY for further examination, job number AJ0000492580 relates.

- X0000643799 - 1 x Brown exhibit bag containing 1 x Orange towel located on floor of hallway inside front door
- X0000643806 - 1 x Brown exhibit bag containing 1 x Brown plastic knife handle located in toilet water in bowl, bathroom
- X0000643803 - 1 x Brown exhibit bag containing 1 x Pillow

On 26/06/2016 D/Sgt SCHIBECL examined the following exhibits and created sub exhibits. These 7 sub exhibits were then conveyed to FASS via Toll Priority Consignment note L000NAT4ZA, arriving at FASS on 28/06/2016. Of note D/Sgt SCHIBECL states that the pillow is completely saturated with blood, with no areas to sample would not be contaminated with the deceased blood.
