Narrative:

About 3.45pm on 18/01/2017 DSC STAPLES attended the home address of Paul TEN - BRUGGEN-CATE, being [REDACTED] Kurrajong Hills 2758.

Paul stated he bought the premises at [REDACTED] Castle Hill and leased out some of the bedrooms. [NP210] (also known as [NP210]) rented out one of these rooms. [NP210] was an [REDACTED]

Paul described their relationship as initially landlord / tenant however over the years Paul became [NP210]'s carer. At no stage were [NP210] and Paul in an intimate relationship. Paul stated [NP210] was promiscuous. He did go to bath houses.

[NP210] was about five foot three / four inches tall, slim / slender and was Asian / Malaysian in appearance. Paul gave permission for DSC STAPLES to take a photograph of two photographs of [NP210] which he showed to her. These photographs depicted [NP210] in about 2006 and 2010.

Approximately in 2000 [NP210] went overseas with a friend and became very ill in Crete. Upon returning home he informed Paul [REDACTED] in 1997. [NP210] also was a [REDACTED]. It was the [REDACTED] which made him progressively ill and as a result he went into [REDACTED]. [NP210]'s family were [REDACTED]. He died at Blacktown Hospital in 2011.

Paul is a nurse and cared for [NP210]. He had a clinic room in his house in Castle Hill. Paul supplied details of the medical care which he gave Paul over the years. Paul eventually got a Carer's allowance to look after [NP210]. He had ten good years living with Paul in Castle Hill.

Paul did not know [NP210] in 1995. Paul has none of [NP210]'s property. Paul was the Power of Attorney of his estate. There was very little there. All [NP210]'s keep sakes went to his nephew [I294]. This included all of [NP210]'s diplomas and diaries. According to Paul, [NP210] wore very little jewellery. A number of items (being mainly clothes) were placed inside his coffin.

Over the years [NP210]'s family became Paul's family and vice versa. [I294] and his wife [REDACTED] got married at Paul's house. He does not have a phone number for [I294] however they do Facetime one another regularly through an unknown app. The last time they spoke was at Christmas time. Paul provided an email for [I294] being [REDACTED]

Before [NP210] died, Paul had a conversation with [I294] and informing him that [NP210] was [REDACTED] and [REDACTED], which apparently [I294] responded well to the news. [I294] and [NP210] were very close and [I294] was a frequent visitor to the Castle Hill house.
