Brief Description: On 13/01/2017 DSC CLANCY received from Dr David BRUCE (FASS) a summary for the DNA results for SF SKARRATT (the investigation into the death of Kenneth BRENNAN from 1995). This seven page document is only for the items which were entered on EFIMS. There has been other recent testing carried out on stored DNA extracts under the case number FS162671, refer to linked product OD-15.

On Wednesday 18 April 2018 Dr David BRUCE was contacted by DSC CLANCY. The forensic report which was created for this investigation dated 13 January 2017 was discussed in detail. It was confirmed that Male 'A' profile is Kenneth BRENNAN. Male 'B' profile was located on the inside front of the YSL green underpants, just below the waistband. A sample was taken from a condom located on the toilet seat which was a mixture of the deceased (Male 'A' profile) and Male 'B' profile. According to Dr BRUCE, at this time there is no further testing which can be conducted on Male 'B' profile.

Male 'B' profile is currently on the National DNA database and will remain there.

Dr BRUCE confirmed all blood samples from nominated suspects which were obtained by the original investigators have been compared to male 'B' profile, with no match, refer to linked product.

Dr BRUCE stated he needs to complete a further report clarifying the status of the DNA results from FS95/444. It must be noted none of the exhibits from this report are on EFIMS.

On 02/08/2018 DSC CLANCY had a conversation with Dr BRUCE. He provided the report for the summary for the DNA results for FS95/444 (job number AJ00738158), refer to attachment. Of interest there is a mixed profile of Male 'A' profile (BRENNAN) and Male 'B' profile (unknown) on the inside and outside of the condom (item 12) which was located on the rim of the toilet at the crime scene. A further hair has been located which is currently being tested. It is anticipated this testing will take up to 2 months to obtain a result (item 6b relates).
