1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated anything which I know to be false or do not believe to be true.

2. I am 42 years of age.


3. On Tuesday 26th June, 1995, I went to the my old unit at Elizabeth Bay. NP214 was with me and we went and started packing all my belongings. NP214 was helping me and while cleaning up I noticed that some items of mine were missing. One thing was a "Cock-ring" which is a piece of body jewellery that Ken had given me. It is a chrome metal ring which is about 2 inches in diameter and stands about 9 cms tall. You place it around your penis and testicles and it keeps your erection. Ken would never use the 'Cockring' because it did not fit him, but if we had a threesome, I would often use the 'Cockring' to maintain my erection.

4. Also missing was a set of keys, they were two keys on a

ring, the key ring was like a cylinder. These keys belong to I282 home address at Petersham. I had the keys because I do his housework, I last saw the keys in the right hand side drawer of the bed head, closest to the bathroom. I last saw them about two weeks before Kens desk. Ken had never used these keys and never had cause to use them. I282 had given them to me two years ago.


5. The night that Detective MOSS and ROSS took me back to my Elizabeth Bay apartment, I found a packet of 'Strepsils' and I thought that does not belong to me or Ken, so I pointed it out to the detectives. When I saw them, I thought it was strange because neither me or Ken had a cold. The Detectives then put the packet of Strepsils into a plastic bag and took them.

6. This Tuesday 26 June, 1995, when I went to the Elizabeth Bay apartment with NP214, I looked in the cupboard underneath the sink on the right hand side and on the top shelf, I removed some cleaning products to pack and I found a long piece of cardboard with plastic cover. The plastic cover was threaded through the cardboard. I thought to myself, I've touched this because I thought the guy might have bought this to murder Ken. I thought straight away that the knife that killed Ken could have been in this packet.

7. In the unit Ken and I had a carving knife which had a rust coloured plastic moulded handle with a stainless steel blade. It was straight along the top and the other side curves to a point.

It was about 12 inches long, the handle was about 5 inches long. The knife was normally kept in the kitchen in the cutlery drawer which was the top drawer on the right hand side as you face into the kitchen. When we tidied up the other day that knife was missing.


8. While we were cleaning the kitchen the only thing missing was that knife I just mentioned and a large frying pan. The frypan was a teflon non stick, it was black enamel and it had a pattern on the base of the frypan which had the words 'Ceramic' and another word I can't recall, this was written in white. The handle of the frypan was black moulded type of plastic I think it is called baker light and it had a silver piece at the joint where it connects with the handle which had a Phillips head screw attachment. I owned the frypan and most of the utensils in the kitchen. I bought the frypan from Woolworths in the city and the knife was bought about the same time from Woolworths.

9. The only other thing missing out of the apartment was Kens shoes. I think they were about a size eight and a half. They had a very big thick like a tractor sole, they were a brown leathery suede, boot, about ankle height, they were lace ups.

10. Since Kens death I have been living with NP214 at [REDACTED] Fullerton Street, Woollahra, NP214 has sold the unit and is moving out to a new apartment in Newport. At this stage I don't know where I will be moving to. I've had all my mail re directed to Peter PASCOES at [REDACTED], Woollahra, his
