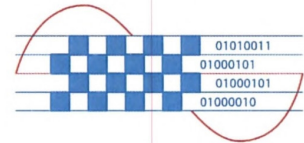

Background:

About 5:00pm, Monday, 12 June 1995, the naked and bloodied body of the deceased, Kenneth BRENNAN, was located by his partner, [REDACTED] NP215 in the unit they shared at [REDACTED] Onslow Avenue, Elizabeth Bay.

Suspects and persons of interest in this matter are [REDACTED] NP215, [REDACTED] NP214, [REDACTED] NP189, [REDACTED] NP190, [REDACTED] NP188 and [REDACTED] NP204

Cause of Death:

Approximately 15 stab wounds to the length of his body, with the fatal wound penetrating his heart.

General description of crime scene and exhibits:

The walls, floor and other items within the premises were smeared with blood. A large number of swabs were taken of same, and water samples were taken from the kitchen and bathroom sink 'S' bends. A shoe print (in blood) was lifted from within the kitchen floor, which was compared and found not to belong to BRENNAN, [REDACTED] NP215, [REDACTED] NP214, [REDACTED] NP189 or [REDACTED] NP190. Two condoms were located in the toilet bowl and a further condom on the toilet rim. A broken knife blade was located on the floor in the main bedroom and the handle was located in the toilet bowl underneath the two condoms. Various hairs were recovered from the main bed and from the deceased's hands. A blood stained and damaged frying pan was located in the main bedroom. A pair of Yves Saint Laurent brand underpants was located in the bedroom and the ownership of this item was not confirmed. A number of crime scene photographs have been attached for reference.
