- 6. Both these chat lines work the same way. I ring the number and have the option to leave a message for other callers to listen to. These messages can be anything from describing yourself to talking dirty. Most people don't leave their name in the messages. When I leave a message it is available for everyone else to listen to. There are options to either leave a message for specific people who have already left messages or you can press the option to be live connected to someone else who is on the phone to the chat line. You have to stay on the line and wait for callers who are interested in you to receive the messages or be live connected.
- 7. When I ring the chat lines I usually live connect to others so I can talk to them directly. I usually just talk dirty with them for a while. I have arranged to meet a couple of guys from chat lines in the past but the last time I did that was about 2 years ago. There is no way of getting someone else's phone number from the chat lines unless they leave it in their message or give it to you when you speak live with them. Very few people give out their phone number on the chat line and the chat line actually has a warning telling people not to.
- I work full time for which is at solution Silverwater. I've worked there since November 2001. I work Monday to Friday 6.00am to 2.00pm and on Sundays 6.00am to about 12.00pm depending on the amount of work required.
- I don't own a car or have a driver's licence so I get around on the train. I catch the train from Westmead to Auburn each day for work.
- 10. On Friday 25 September 2009 I finished work at 2.00pm as usual and caught the train home. I had a few beers and watched the footy, Bulldogs versus Parramatta. After that I went to bed. I didn't ring anyone on my mobiles or home phone on Friday night. I just went straight to bed after the football.
- 11. Early on Saturday morning I woke up to go the toilet and was feeling horny so I went out into the lounge room and rang a chat line from my home phone, I don't even remember which number I rang. I left a message saying I was horny and looking to chat with someone. I stayed on the line and got a message back. I can't remember what the message said but they must have been interested in live connection so I pressed the option to be connected live to this guy. I only spoke with the one guy on Saturday morning.

- 12. I remember this guy who I spoke to said he was 25 years old, and sounded like he was aussie. He didn't tell me anything more about himself except that he was in bed. We talked about sex and what we would do like to do to each other while I had a pull. I don't remember who disconnected the call on this occasion. Usually after I've finished having a pull I'll just hang up.
- 13. After this call I went straight back to bed. I woke up about 9.00am, had a coffee and then caught the train about 10.00am into Parramatta where I went to the butcher on the fifth floor of Westfield Shopping Centre. I always go to this butcher to buy my meat. I caught the train back to Westmead after this and stayed at home the rest of the day.
- 14. I don't know anyone by the name of Anthony CAWSEY or anyone that lives in Redfern. I don't go to the city at all except for the Mardi Gras which is in February. I have never been to Centennial Park and don't even know where it is. The last time I had sex with a guy was a couple of months ago. I don't use the internet at all.
