- This statement made by me accurately sets out the evidence that I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I will be liable to prosecution if I have wilfully stated in it anything that I know to be false, or do not believe to be true.
- 2. I am 37 years of age.
- 3. I am the Sole Trader of DGM Communications which operates a gay telephone chat/dating service called "Manhunt". I have operated this service since 1999. This service is primarily used for men seeking to make contact with other men. It is used for various means; chat and or phone sex and or meeting up in person. The service has thirty (30) incoming telephone lines. The server which handles all calls is located at the "Equinix" data centre Mascot. The service is only accessible via the telephone. There is an internet site of the same name, which is totally separate and unrelated.
- 4. The Service accessed by numerous telephone numbers. Some of which require the caller to pay for access in advance using a credit card or by calling a 1900 number where it is charged to the caller's phone bill. The main service number is 8303 0369. There are also free/promotional lines which the business receives no income from, there are only two numbers being 8303 0303 and 8303 0333. There are 1900 numbers which are charged with a fixed fee of either \$30 for 200 minutes of access, this number is 1902 268 500. Or 1902 268 509 for 100 minutes of access for \$15. After registering and paying for this time, the caller is given a membership number and pass code. They then have to hang up and then dial into the main service number. There are further 1900 number which are charged per the minute.

- 5. Once you access the service you are prompted to record and introductory greeting. This greeting is then played to other callers. The caller listen greetings of other people currently on the system. Whilst listening to a greeting you have the option to either skip to the next greeting, send the owner of the greeting a recorded message or thirdly request to connect live to that caller. Once a caller hangs up, their greeting and any voice messages sent to other, during the call is deleted. During a live connection callers are directly connected to each other as in a regular phone call, however each caller's phone number remains undisclosed. It is known that once callers have established contact with someone they are interested in they may choose to swap phone numbers and call each other directly, disconnecting from the service.
- 6. The system automatically generates a number of log and statistical files. At 4am each morning for the previous 24 hour period a file is generated and deposited into a directory. Every week I download these files for the purpose of charging the relevant credit card. Within the file are a number of other files, one of which is a log file detailing calls made to the system, the time the call was made and if available, the number of the person making the call. However if the person making the call is calling from a private number or has hidden their number, no caller ID is available to be recorded.
- 7. In this log file is the time and date a call has been made. Which one of the thirty incoming lines the call has terminated on. What service number has been called, the telephone number of the caller if it has not been blocked, membership number of the caller if provided, and the time balance if available. The other numbers contained in the log file I am unsure what they actually mean, but I am finding out.
- 8. I am giving Police a copy of the file for starting at 12am for the 25th of September 2009 and 26th of September 2009.
