STATEMENT OF A WITNESS

STATES:

1. This statement made by me accurately sets out the evidence that I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I will be liable to prosecution if I have wilfully stated in it anything that I know to be false, or do not believe to be true.
2. I am 24 years of age.
3. I arrived in Australia in April 2006, from my home country Sierrre Leone. I am on a Refugee visa as my country is at tribal war with each other. Therefore many of us had to flee this country. I arrived at Sydney Airport with my two sister's [REDACTED] and [REDACTED] (38 years of age). Before I left Sierrre Leone, I started to smoke cigarettes when I was about 14 years of age. I gave it up whilst I was living in Sierrre Leone, but have taken it up smoking cigarettes again since I have moved to Australia. Currently I do not have any money so I collect cigarette butts and empty out the tobacco and rolled the left over tobacco in A4 paper and smoke it that way. I also use tallyho papers for rolled cigarettes. I smoke about two or three a day.
4. Since I have arrived in Sydney I have lived at Blacktown ([REDACTED]) and then in Marrickville ([REDACTED] Marrickville) in which I was evicted on 25 May 2008. I was unable to pay the rent therefore I was evicted by the land lord. I lived at Blacktown with my sisters until I moved to Marrickville and lived there alone.
5. Since moving to Australia I have worked at TNT [REDACTED] My job was to assemble glass lights. This was a contracted job and in finished in May 2008. I have not been employed since

this date. I have not received any unemployment benefits since 2008. At present I do not have any income.

6. I currently reside in Centennial Park, located between the suburbs of Kensington, Paddington and Queens Park. I have been residing there since April 2009. I reside on my own and keep to myself. I don't have any possessions to carry or to hide. When it rains or it is cold I stay in a building which is located on Dickens Drive next to the Duck Ponds. This building is made of Sandstone and is quite large, with one bench table inside and five on the outside. I normally sleep in on southern side of the building. I often use this place to sleep in, some times if people are there I won't sleep there. I will find somewhere else to sleep with in the park. I am aware there are other people sleep in the park, but I'm always alone.
7. Whilst I have been living in the park, I have seen males in there who appear to be there to indulge in homosexual activities. The homosexuals make a sign at me and if you acknowledge that sign it means you are interested in homosexuals and if you ignore it, it means you are straight. I am not a homosexual, so I ignore the homosexuals in Centennial Park.
8. I often see violent being committed in Centennial Park usually on Friday and Saturday nights. This violent is usually done by people passing through the park at night who appear to be drunk. I have been attack and physically assaulted, whilst I have been residing in the park, just because I was sleeping in the park.
9. On Friday 25 September 2009, I was in the Centennial Park. I was staying under a tree near Alison Road, Kensington. I set up a little camp there with a park bench as my bed. This is where I stay if it is not raining. I stayed there for most of the day. That night I slept under the tree on the park bench. I woke up about 3.00am that morning and walked on Anzac Parade down to Kensington. I walked down to the newsagency located at the intersection of Anzac Parade and Todman Avenue. I grabbed one or two old newspaper that are left out the front of the Newsagency. I continued to walk south on Anzac Parade until I reached the University of NSW, located on Anzac Parade, Kingsford. As I reached the University the sun was starting rise, so I decided to go back to Centennial Park. I walked back to Centennial Park the same way as I had come from. I walked north on Anzac Parade until I came to Centennial Park. I returned to my bench. I stayed there for a while until I became thirsty. I got up and started to walk towards the football ground where there is a shed where I get my water from.


10. As I approach the shed where I get my water from I noticed there was police tape all the way around it. I notice there were many police near the tape. I went to another place and got a drink of water, soon after that I returned to the park bench located near Alison Road, Kensington.

11. All of Saturday I hung around the park bench all day. I noticed there was a lot of people around the football field where the Police tape was.

12. On Monday 28 September 2009, I read the Wentworth Courier that a male had died on the Busby Pond, Centennial Park. It also read it was a hate crime. There was a picture of a male who had his hat turned backwards and who was smiling. I have never seen this male before.

13. I do not know what to this male on Saturday 26 September 2009.
