You are, great. Thank you. Um, and can you please state your full name please Gail, and your date of birth?

Q29 OK. Moses, as I said, I'm going to ask you some further questions.

Q31 Now I understand that you have been interviewed by the police

previously.

A Yeah, I was interviewed at Maroubra. Mar, I think it was Maroubra

Police Station.

Q32 Yes.

A Yeah.

Q33 You, you, how many times do you remember being interviewed by the

police?

A Uh, Twice.

Q34 Twice?

A Yeah, I think it was, the first time it was, they didn't record it. It was

not recorded. They just write it down. Then the second time I just went there. I can't remember what happened, but, was not recorded

using this machine.

A I can't remember that either.

Q42 You can't remember that?

A No.

Q43 OK. The information I have is that that's happened three times.

A Yeah.

Q44 You were interviewed, um, once at Waverly Police Station, Once at

Maroubra Police Station.

only ask me some questions in Maroubra Police Station.

A But I was, um, it was never recorded.

A Yeah.

Q52 OK. So you remembered being, I was probably a bit too vague with

think you were interviewed by police about having a knife at the

Q54 Do you remember that?

A Yeah, yes. I got charged for that.

Q55 You did get charged for that.

Um, so I just want to tell you that I have watched all Q60 those previous interviews. Α Yes. Q61 And I have, um, I have a transcript here of what you said in those previous interviews if we need to, if we need to refer to it. A Yeah. OK. So I know that in a previous interview - - -Q62 Α Q63 --- you spoke about a time when you were approached by a man for

you for gay sex twice in 1 hour.

A Yeah, I remember that. I remember, um, clearly. Um, it was not the victim, the alleged victim. It was the person I did the armed rob, the person I robbed, the mobile phone I robbed from the person. That's

gay sex in Centennial Park. And you said that this man approached

the actual person I was talking about.

Q65 Can you explain what you mean?

A I mean the, the victim, because I got charged with armed robbery - - -

Q66 Yes.

A I remember the, um, the police asked me, um, do you know this fella before. I said, Nah. I say, I'm, I first met him in the, in, in front of Centennial Park.

A Um, he asked me for gay sex. Then he walk away. I walk into the park. And that's where I walked behind him and I rob him of his mobile phone.

Q68 OK.

A Yeah, that was the, the person for the armed robbery.

Q69 That's the person for the armed robbery?

A Yeah.

Q70 [10:50] OK.

A Yeah.

Q71 What I'm going to do Moses I, is I would like to ask you some more

questions - - -

A Uh-huh.

Q72 --- about, um, about that event.

A Yeah.

Q73 OK.

A Yeah.

Q74 So, you said that the first time you saw him was at the main gates to Cent - - -

Um, that's when I, that's, that's when I went and rob him. I went from the other side of the park, I come out on the other, on the other entrance, and robbed him, robbed him of his mobile phone.

Q78 All right. I'll just go through, um, the questions that I want to ask you, Moses.

A Uh-huh. Yeah.

Q79 Um, you mentioned before in one of your earlier interviews - - -

Q80 [10:51] --- that guys make a signal to each other to say that they are interested in gay sex. That they, that men have a signal. Can you tell me what that signal is for gay sex?

A No, I, I, I'm, I didn't say that. I said he approach me in the, in the, he approach me. He said something but I didn't listen to it, you know. I tell him 'Go away', you know, like, that.

Q81 OK. All right. So you said in the interview, as I said I have a transcript of the interview here. You said in the interview that the man was in Centennial Park for 1 hour or more.

Was he, was he doing anything while he was talking on the phone? While he was talking sex talk on the phone was he doing anything? Α No. Q87 And how long did you hear him make the sex talk on the phone? He was, he was walking around right in front of me, no more than a A few times. Q88 Yeah. A Yeah. Q89 What did he, what did he do when he finished talking on the phone? A He started walking on, on the other side. Because there's a park there and there's another park there. that's where the tennis court is. And he, he went, he walk in front of me and go, and walk into the, into the street. So as he start walking up the street, then I went into the park, and when I come out from the other side, he was still talking on the phone, on, on the other side of the fence. That's when I, that's when I walked outside and robbed him.

Q91 So the second time, the second time that you saw him ---

A Uh-huh.

Q92 --- was he doing anything with his hands or body?

A No, he was talking on the phone.

Q93 He as talking on the phone?

A He was still talking on the phone, yeah.

Q94 OK. In a previous interview you said that, um, the man forced attempt ...

with you.

A Look I don't know about that.

Q95 What, I was going to ask you what you meant by that?

A I can't remember any forced anything on me.

Q96 Yeah.

A He was just talking on the phone, like, the first, the first time I saw

him.

Q97 Yep.

A Like I thought that he was making sexing, you know, because he

keep, he keep walking in front of me and talking on the phone. Yeah,

that's what I thought.

Q98 When you say, walking in front of you, are you saying that he was

A Back and, back and forth, yeah, yeah.

that, so you're going to draw the --

backpack.

A No, they arrest, they arrested me with knife in my, in the backpack.

A They, they asked me on The Boulevarde there, they asked me, 'Why

you carrying the knife for?' I said, 'For protection'. 'Cause, like, that's

why I got arrested for the assault.

Q134 Yes, I remember that.

A Yeah.

Q135 And when you say protection, protection from what?

A People, people attack other people in the street.

Q136 OK.

A Yeah.

Q137 You were also, when you were also interviewed, um, um, by police, they found, um, a number of, um, knives in your campsite that was in the drain.

A Yeah.

Q138 You know what I'm referring to don't you.

A Yes, yes, yes.

Q139 OK. Um, and when you were interviewed by the police that day, on the same day that you were found in the drain, uh, in that interview you talked about having knives and sometimes carrying those knives in a backpack.

A No. I, I can't, like, most of the knife there, I found them in the, in the, because people go there and barbecue.

A There's a barbecue stand there. People barbecue, so most of the time if I'm walking there because there's a tap there. I go there and get water to drink. There's some knife around, so I just pick them up there and, and have them in my possession.

A Yeah.

Q142 All right. Um, so Moses, did you carry knives with you in a backpack?

A Yeah, they arrest me, they arrested me with a knife in the backpack - - -

Q143 Yeah.

A --- in The Boulevard there.

Q144 On The Boulevard.

A Yeah

Q145 So, on other times did you carry a knife - - -

A No. Uh-uh.

Q146 --- with you in backpack?

A No.

Q147 What sort of knives did you, did you own when you were living in

Centennial Park?

A I can't remember. Most of the knife, I find them there in the park

there. There were knife there in the park.

Q148 And how many knives do you think you owned then?

A I can't remember how many knife I owned. But they were, there were

a few. 'Cause I remember when I got arrested they fine me for those

knives.

Q149 When you got arrested.

A When I got arrested, yeah.

Q150 [11:01] In the Boulevard you mean?

A When I got arrested in Boulevard they take me to Waverley Police

Station. That's where they, they go through the bag, they find all the

knives.

Q151 I think they found one knife.

A Uh, I, I'm not sure how many - - -

Q152 Yeah.

A --- how many knife was there. But they said, the police, they, later

on they fine me for, I think it was six or seven knife there. They, they include, they, because the people investigating the murder find some

other knife there, in the, in the pond.

Q153 Yes.

A They take those knife and include them in the other knife they

arrested me in Boule, in Boulevard, and charge me with all of them,

all those knives together.

Q156 For all of those knives, you, you believe?

A Yeah.

Q157 OK. I might just show you a picture of some of those knives, see if you recognise them. I'll just show you, I'll just show the camera that's the first image. I'll just label that photo 1. Do you recognise that, that photograph, Moses?

A I recognise, I recognise it because of the shoe.

Q158 Yeah, what can you tell me about those?

A Uh, I remember I, I got the shoe from the OP Shop there. These two sandals, yeah, and there, there was some knife there when the police came.

Q159 OK.

A Yeah, there's, that's the knife there.

Q160 [11:03] And those were, were those your knives, Moses?

A Yeah, this, this are the knives I found there in the, in the park there.

Q161 OK.

A Yeah.

Q162 OK. And these are some of the, each of the photographs are labelled

differently. I'll just show the, show the camera. Do you recognise these knives, Moses?

A I can't, I can't recognise it, because there were, there were a few knife

there. Is this knife from the same scene?

Q165 That's all right. Can I show you, um ---

A Most, most of the knife I was having there in this, in the, in this, in the area where the police came, they all got this, um, they are not sharp in the, in the, like, for example, this, they, all of them were like that.

Q166 Yeah, not all of them. You can see the other one here is not curved.

A Yeah, the other one was like that, but most of them was, were like

this.

A Yeah.

Q168 I don't think most of them - - -

A I can't, I can't recall this one.

Q169 Yeah.

A I remember this one was on the bag. This one was in the bag. This

knife was in the bag they arrested me with. The bag - - -

A Yeah, at The Boulevard, yeah, yeah.

Q171 OK. What about this knife Moses? Do you recognise that particular

A I was camping, first, first of all, I was camping around, there's the field there. I think I was camping here before, around here, so that's the main street there.

Q194 That's The Grand Drive.

A Yeah. I was c, I was - - -

Q195 Do you want to indicate - - -

A Which one is Paddington? Which, wh, look, I'm no good at, I'm no good at map.

Q196 That's OK.

A Which one is Paddington? This is Paddington or - - -

Q197 Uh, Padding, Paddington would be up this area here.

A Oh, yeah.

Q198 So Busby's Pond. Um, Kensington is this area over here.

A Oh, yeah, yeah, I think it was around Kensington area - - -

Q199 Yes.

A --- there was a, there was a campsite there. Because when I first

spoke to the police I showed them where I was camping before.

Q200 Yes I remember.

A Yeah, the police asked me about the camp. They went there, and they took me to, because we went, went through there, I was walking around at that time to get, to get water. I was coming to around this area, then I saw the police officers. They stopped me and start asking me, they say, Who are you? What are you doing here? And I, I told them straight up. I, I'm homeless.

A I, I'm living in the park there and I, they asked me, where, where do you, where do you sleep. I told them I, I camp there. I was camping around Kensington area.

A Yeah. And that was it. They took me to the police station and questioned me about it. I say I got nothing to do there. The only crime I commit, I was camping there when the incident happened.

A Yeah.

Q250 Michelle Obama, Barrack Obama, Solomon Tutu and Coco Tee?

pirate of Somalia boat. And there's some people and some people

with guns.

A Yeah.

Q253 Did you draw this picture, Moses?

A No. No.

Q254 OK. There was also another notebook and that's the cover.

A Yeah.

Q255 And there's also again, it's a fairly large sized notebook, and inside

that notebook there was also, um, a, a picture of a man which is quite

similar I think to - - -

A Yeah.

Q256 --- the other ---

A To the other one, yeah.

Q257 Yeah, do you agree?

A Yeah.

Q258 And inside that there was also, um, this which is um, uh, this which is

Mosley, uh, Mos, Moses?

A Moses, yeah.

Q259 Yeah. Is this, would this be your notebook?

A No.

Q260 No?

A No.

Q261 [11.15] OK. And Moses also in, um, in that campsite there were a

number of newspapers as well.

A Yeah.
