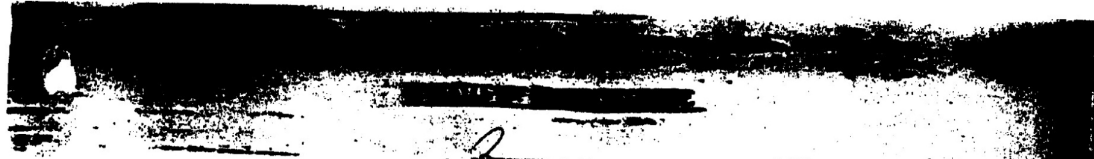

 residency but had been approached by girl for a further
 payment of \$30,000-00. MP became terrified but wouldn't
 detail reasons, had arranged marriage to avoid making
 name in Germany, also had been only at ABC for about

12 months prior to disappearance, used to regularly see M.P. continually referred to him as being absolutely delightful etc etc. Last saw him on an unknown Sunday afternoon attended his flat on a Sunday afternoon unknown date found flat open all locks intact, no sign of M.P., thought initially that M.P. had entered homosexual relationship with unknown male and had disappeared with that person, no further contact to this date.

3/ call to German Embassy Canberra [redacted] said national service was universal to age of 28 years allowing for studies, foralties serve, 10 years in gaol, further enquire Federal German Police and Bundeswehr.

4 recall to SMYTH, the time said he saw M.P. on unknown Sunday spent afternoon with him, around 5:00p unknown male arrived to take M.P. to concert at night club unknown details, present for about ten minutes, last time that he saw M.P. said he to flat on following Tuesday and found fence open as described before.

 mid 1982. arranged marriage June 1983 witness has
 german friends of MP. MP fiercely anti-semitic and
 MP would occasionally get her money \$10-00 - 80-00 did not
 work as a prostitute had not seen MP since June 1983
 stated to be obtained 9/9/83
 statements attached

21/10/83 telephone call from Mrs BAUMANN - SEER (sister of MP) said:
 1/ MP had been rejected for military service on medical grounds
 and had been rejected prior to travelling to Australia
 2/ had travelled to Australia to be more successful with
 his music, amicably with father no greater than
 any of rest of family (five brothers & sister) and only because
 all raised in strict Catholic household,
 3/ had no knowledge of father's bisexual/homosexual

 4/ no money given to M.P. for marriage or any
 purpose no large sums
 5/ father worked in factory not-composer only involvement
 in music played accordion
 6/ family originated from Baden/Wuerttemberg
 7/ only knowledge of marriage was when M.P. retired

29/11/93 1/ NETMAIL and INTERPOL re enquiry update Germany
2/ telephone call to SENEVIRETNE, had no idea of trip
to N.Z. even though still in relationship on period,
no knowledge of trip to Byron Bay, now adds that
when she spoke to SMYTH, he also said that MP may
have gone to Africa. SENEVIRETNE now becoming
very evasive and showing desire to avoid enquiry.
