ISSUE:

Request for SCC assistance regarding the disappearance and alleged murder of Mr Peter Karl BAUMANN born 20.4.1957 – E909939200037 / C5602949.

BACKGROUND:

On 27 October 1983 Mr BAUMANN was reported missing at Waverley Police Station (Eastern Suburbs LAC). Since that date investigations have been conducted by Eastern Suburbs LAC and the Missing Persons Unit. The body of Mr BAUMANN has not been located.

In 2005 the case was reopened and has been subject to further investigations and reviews by police attached to Eastern Suburbs LAC.

There are suspicious circumstances surrounding the disappearance of Mr BAUMANN. Please refer to attached papers and an Investigation Plan prepared by Sergeant Darren SMITH attached to Eastern Suburbs LAC.

COMMENT:

Further investigations are required to be conducted. Although the disappearance of Mr BAUMANN allegedly occurred within Eastern Suburbs LAC, further potential investigations are required to be conducted outside the Sydney metropolitan area and perhaps abroad.

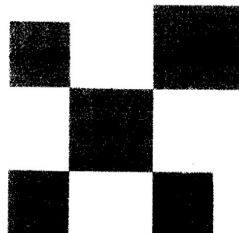
The case requires specialist investigative support. It is my view that the case should be referred to the Unsolved Homicide Squad for review and the investigation to be fully staffed and led by SCC.
