ISSUE:

Operation Firenze request for outstanding material in relation to long term missing person Peter BAUMANN, E909939200037, C5602949, trim number D/2010/173773 relate.

BACKGROUND:

Peter BAUMANN was reported missing on 27 October 1983. As of this date, BAUMANN has not been located.

In 2008 a brief of evidence was prepared by Detective Senior Constable FIELD for the NSW Coroner in relation to the disappearance of BAUMANN. A P79A was also completed.

On 4 August 2009 an inquest was held into BAUMANN's disappearance at Westmead Coroner's Court. It was determined it is highly likely BAUMANN is deceased but that could not be elaborated.

COMMENT:

On 13 May 2011 I received carriage of C5602949 from Detective Senior Constable FIELD. Associated with the case was a file from Missing Persons Unit requesting additional information.

It was determined the information sought needed to come from a family member of BAUMANN. The only locatable family member was BAUMANN's sister, Anna BAUMANN, who resides in Munich, Germany.

On 22 July 2011 I was granted access to eaglei investigation 'Strikeforce Blissett'. I obtained all documents from this strike force and have attached them to this report.

On 25 July 2011 an iask request was completed, requesting assistance from Interpol to complete the DVI forms and to obtain a sample of Anna BAUMANN's DNA.

On 26 October 2011, the iask was marked as complete. The attached documents included the DVI form, completed by Anna BAUMANN and information relating to the oral cavity smear of Franz BAUMANN. The request had a cover sheet from Interpol Canberra explaining the last dental examination of BAUMANN was on 9.2.76 where nothing was detected and no associated documents were available.


