


ANNEXURE

1. Inquiries with Immigration Status Services (Old Movements), Dept of Immigration to obtain details on witness Hiroshi HAMASAKI aka Hyuma HOSHI, resident in other flat at Cross Street with Baumann. Last persons to seen him (possibly) at time of disappearance.
2. Japanese National Police to obtain statement from HAMASAKI. HAMASAKI well know anima cartoonist in Fukouka Japan.
3. If travel to W/A not possible, file to W.A. Police with prepared questions to interview SMYTH & KEASBERRY.
4. Inquiries with Waverley Council and State Transit Authority re [REDACTED] Artlett Street, Waverley. [REDACTED] Artlett Street, then vacant land owned by the State Rail Authority in 1983.
5. Contact David O'CONNOR, former director of [REDACTED] re knowledge of SMYTH & KEASBERRY (Resides [REDACTED]).
6. Inquiries with German consulate re Baumann re-applying for West/East German passport, identification/German under BAUMANN/ ANN/MOLTZAM.
7. " " " " " " " " " " changed his name to either ANN or MOLTZAM.
8. Check Immigration Status Services re movements in names of ANN/MOLTZAM.
9. Dental records from Germany.
10. Bavarian State Police to obtain statement from Frau BAUMANN - SERR regarding her inquiries in Australia 1994, particularly with Cherie FOSTER.
11. Statement from Kevin Anthony SMITH resident of [REDACTED] Glebe Point Road, Glebe where Baumann lived at time of wedding and period before and after. Currently residing in [REDACTED].
12. Statement from Cherie FOSTER'S then boyfriend John PAUPERIS at time of wedding. Supposed to have been aware of all arrangements and met Baumann on a number of occasions. Currently resides at [REDACTED].
13. Speak to Sharmalie SENEVIRATNE re her contacts with SMYTH over rumour of BAUMANN going to Africa. (Resides [REDACTED]).
14. Statement from her cousin of Hamish PEARS as to circumstances of attending Baumann's flat, finding letter and going to Allan SMYTH's house in Artlett Street. (Resides [REDACTED])
15. Statement from her sister Diliania SENEVIRATNE who accompanied her the next day to Baumann's flat when she spoke to HAMASAKI.

16. Inquiries with German Consulate as to if personal identification was returned to them in 1992 by Ruth BINNEY as family in family in Germany never informed.
17. State Archives re Occ Pads from Waverley, Bondi and Rose Bay for 1983.
18. Locate and obtain statement from Robert GOVER, worked with Baumann at A.B.C.
