Re: Peter Karl Josef Baumann

I refer to your letter of 26th September, 1991 requesting information in relation to your missing brother.

I advise that my records are confidential and I am unable to supply any details of any marriage to anyone other than the two parties involved. However, I am able to undertake a search of my records to ascertain whether your brother has died. I advise that I only hold records for New South Wales, and you would have to contact each State individually for Australia-wide coverage.

I enclose herewith an application for Death search, and you would be provided with a Result of Search Certificate or a Death Certificate, upon payment of the appropriate fee. I enclose a scale of fees for your information.

I would suggest that you persevere with the Salvation Army as they are more able to undertake the type of searching you require, through other sources.

It should be noted that any fees forwarded to this office should be made payable in Australian Dollars, by way of Bank Draft payable on an Australian Bank, or by International Money Order.

I wish you luck in your search.

It would appear from your letter that your brother is resident in New South Wales, not Victoria. This office only records Births, Deaths and marriages that occur in this state.

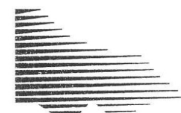

I have been trying to find my missing brother Peter (born 20.04.1957) for ten years now and I only learned a week ago that he was reported to The Police, Missing Persons Unit - Sydney, as being missed in 1983.

However he could not be found by the Red Cross and The Salvation Army over these years. I know by means of an application for Death search at the Registry of Births, Deaths and Marriages that he married and I presume that he gained Australian citizenship.

I refer to your letter of 7 September 1993. I replied to your previous letter approximately four months ago (the exact date is unavailable at this stage as the file which, among other matters, contained your letter and my reply, was inadvertently transferred to another office).

To reiterate what was said before, unfortunately any information this, or any of our passport offices holds regarding the issue of a passport to your brother may not, by Australian law, be passed on to another party. This is covered in the Privacy Act as well as the Passport Act.

In Australia, all Australian citizens over 18 years of age are required by law to register with the Australian Electoral Office. This office then produces Electoral Rolls for each electorate in Australia. The Electoral Roll is freely available to the public from the Australian Electoral Office as well as being available in most libraries. Working on the information you provided in your letter, I took the liberty of checking the Electoral Roll for each state of Australia. Unfortunately there was no record of your brother. This could mean one of two things, firstly that he is not an Australian Citizen and as such not listed, or secondly that he has changed his name - and without that new name there is nothing else I can do to assist you.

If you have not already done so, I suggest you contact the International Red Cross in Geneva to see if they can assist you through their organisation. The alternative is that you utilise the services of a private investigator in Australia.

I regret that I cannot be of more assistance however as a Government agency, we are constrained by law regarding any information we may have regarding clients and cannot pass this on.

I wish you luck in establishing contact with your brother

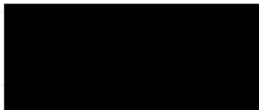
