REQUEST FOR THE ASSISTANCE OF THE FRENCH (PARIS) POLICE.

BACKGROUND INFORMATION

Eastern Suburbs Detectives at the direction of the New South Wales State Coroner are investigating the disappearance of French National Gilles Jacques MATTAINI, born 25/10/1958. MATTAINI was last seen in Sydney during September 1985.

MATTAINI arrived in Australia with his (homosexual) boyfriend Jacques Paul Musy on the 17 March 1984. MATTAINI's visa expired on the 28 August 1984. There is no record of MATTAINI leaving Australia.

At the time of MATTAINI's disappearance he was living with MUSY at Flat [REDACTED], number [REDACTED] Bondi. During September 1985 MUSY was holidaying in Paris. Whilst in Paris MUSY received a telephone call from a friend Vincent OTTAVIONE who informed him that MATTAINI has gone missing, that he had not gone to work at the Menzies Hotel in Sydney and that he had not been home to unit [REDACTED] number [REDACTED] for a number of days.

It was subsequently discovered that MATTAINI's passport, house keys, wallet, credit card and other personal belongings had been left in the unit at [REDACTED] Bondi.

MATTAINI has not been seen or heard from since September 1985. At the time of his disappearance MUSY and friends made enquiries at hospitals, the morgue and police in respect to the whereabouts of MATTAINI. However the disappearance was never formally reported to the New South Wales Police Service.

During 1986 Musy visited MATTAINI's father in Paris. Apparently MATTAINI's father was aware that his son was missing but wanted nothing to do with MUSY. (No further details as to the identity or location of MATTAINI's father are available.)

Also during 1986 Musy shipped MATTAINI's belongings to his family in France.

During 2001 & 2002 the New South Wales Police Service has been investigating the suspected Murders of a number of Gay men in the Bondi Area during the late 1980's and early 1990's. MUSY reported the disappearance of MATTAINI after seeing a newspaper article relating to that investigation. A police statement was obtained from MUSY on the 3 August 2002.

ASSISTANCE SOUGHT.

It would be appreciated if the French Police could make a number of enquires with the family of Gilles Jacques MATTAINI.

Those enquires include:

Details of any correspondence recieved from Gilles prior to his disappearance.

Details and history of any prior suicide attempts by Gilles.

Details that the family may know in respect to the relationship between Gilles and Jacques Paul MUSY.

Whether there are any records of Gilles MATTAINI being alive in France subsequent to Septebmer 1985.

Whether they can obtain any dental or medical records that may assist in indentifying MATTAINI if in fact he is deceased and his body has remained unidentified.

Whether they can obtain any photographs of Gilles MATTAINI from around 1985.

The the families version of the facts as know to them in respect to the disappearance of Gilles MATTAINI.

Any other information that may assist the New South Wales Police Service in either locating or identifying (If deceased) Gilles MATTAINI.

Your assistance with this matter is greatly appreciated.
