We reply to your message dated 08/08/2002, which deals with a request from Interpol Canberra concerning MATTAINI, Gilles, born 25/10/1958, who was last seen in Sydney, Australia in September 1985.

We advise that enquires have been undertaken, particularly into Mrs. MATTAINI, (nee BINDER), Renee, the mother of the subject, who was widowed in 1991. She provided two photographic negatives of the missing person and the following information:

The person MATTAINI, Gilles left France to immigrate to Australia on 29/08/1983. Prior to Paris 9eme with friends named: MUSY, his departure he was living at: Jacques and WYSZNSKI, Anthony. He was employed as an accountant's assistant by the BANQUE PRIVEE DE GESTION FINANCIERE (Private Bank offering Financial , Paris 8eme. administration) at

in Australia he also found work, which suited his skills at the HOTEL MENZIES, at 14 Carrington Street, Sydney 2000.

Mrs. MATTAINI told us that the person WYSZNSKI advised her of the disappearance of her son. He apparently told her that his friend Gilles had advised him that day that he was going swimming in the sea. Also MUSY had said that he had done everything possible, but she had never actually had confirmation that official enquires had been undertaken by the Australian Police.

Also to date neither she nor her husband has officially reported their son as missing to the French Authorities. On the advice of the Australian Ambassador in Paris, Mrs. MATTAINI only requested assistance from the INTERNATIONAL RED CROSS, which announced in June 1993 that their searches had been unsuccessful.

It has been established that MATTAINI, Gilles only contacted his family by telephone. They never wrote letters to each other. The last telephone contact made with his mother took place one week before he disappeared.

The subject has a medical file, which itemized several visits to the hospital, one of which followed an attempted sulcide, and there is a military medical record. However, we could not find any dental record for him at all.

Additionally we have learned that MATTAINI frequently traveled overseas and that he was an amateur scuba diver.

We have not been able to ascertain his precise relationship with Mr. MUST, Jacques, nor whether he might be homosexual.

The person MATTAINI, Gilles, is not adversely recorded with Police or the Gendarmerie. As for MUSY, WYSZYNSKI and OTTAVIONE, we have not been able to check the records we normally search without the sufficient personal particulars for them.
