Hello Ashley

Following our last contacts please allow me to get back to you regarding your request.

Our investigations indicate that the mother of Mattaini Gilles, Ms. Renée Binder, died in the beginning of the year 2017 shortly before our referral.. The latter was the subject of a cremation rendering any DNA collection impossible.

Nevertheless, our research has revealed that she had 10 relatives, of whom 07 are still alive, including a sister living in our department, Mrs Liliane MICHEL born Binder. Would you like at this point in the investigation to have a DNA sample taken from that person?

Furthermore, it should be noted that the additional investigations conducted at this stage by our services did not allow us to highlight evidence on Mattaini Gilles, particularly in the field of medical history or Hospitalization. The various administrations involved do not have (or only very few) elements on the person concerned mainly because the period covered dates back to a long time.

I remain at your disposal for your various requests or orientations in this file and in particular for the formalities for the collection of a family DNA.
