Narrative of circumstances under which death took place. The deceased was last seen about 11pm on Friday the 21 July 1989 by Craig ELLIS, and the deceased had a stated intention of going to a bar in Taylor Square, Darlinghurst. The deceased has not been seen since.

On 24 July 1989, a vehicle owned by the deceased was located near Marks Park, a headland at Bondi, and a known "gay" meeting point (the deceased was homosexual). Later that same day, keys for the vehicle owned by the deceased were located near the waters edge.

A thorough search by the Police Air Wing and Water Police found no further evidence.
