Brief Description: I414 stated he had never met WARREN. He and I88 had both lived in Wollongong and I88 told I414 he had known WARREN. He told him this after WARREN's disappearance was reported in the media. The only thing I414 can recall I88 saying in relation to WARREN was his belief that WARREN had faked his own death and had done so on a previous occasion in another state. I414 stated I88 can not help telling lies. It is I414's opinion that I88 would have made up the story about WARREN for a 'bit of drama.'

He had told [1414] his father was a Policeman when in fact he was a cleaner. It is [1414] opinion that [188] would have made up the story about WARREN for 'a bit of drama'. [1414] last saw [188] in October or November, 1989 and he believes [188] went to South Australia shortly after that.</p>
