

Statement of Ingo ELLENBERGER

Brief Description: On the 31/08/2001, I attended the Tactical Operations unit, SPG and obtained a statement from Senior Constable ELLENBERGER. Constable ELLENBERGER recounts handing over the property of Ross Bradley WARREN to Mrs Kay WARREN. See summary.

Summary:

Para 3: Between 1987 and 1992 was working from Bondi Police Station.

Para 4: On the 26/07/1989 was performing station duty at Bondi Police Station, believes this to be the case as he makes reference to miscellaneous property book A150422 which was issued to Bondi Police Station. The entry relates to property handed in by Det Sen Con BOURIS on the 24/07/1989. The property relates to missing person Ross Bradley WARREN.

Para 5: Notes that his signature appears as the witnessing/returning officer returning the property to Mrs K WARREN from Surfers Paradise. His usual procedure would be to confirm the the ID of the person collecting and cross reference all the property with property listed in the miscellaneous property book, have the collector sign for receipt of the property and he then witnesses that signature. Notes that amongst the property listed there were a set of keys, as usual procedure he would have returned them along with the other property listed.

Para 6 : Other then returning the mentioned property, has no other recollection of any involvement in this matter.

2. I am 35 years of age.
3. Between 1987 and 1992, I was a Constable Stationed at Bondi Police Station.
4. On the 26 July, 1989 I was performing station duty at Bondi Police Station, I believe this to be the case as I make reference to miscellaneous property book number A150422 issued to Bondi Police Station. This entry A150422 relates to property handed in by detective Constable BOURIS on the 24 July, 1989. The property relating to a missing person by the name of Ross Bradley WARREN.
5. I have viewed a copy of the miscellaneous property book and have noted that my signature appears as the witnessing officer returning the property to Mrs K WARREN from Surfers Paradise, my usual procedure would be to confirm the identification of the person collecting the property, cross reference all the property with property listed in the miscellaneous property book, then have the collector sign the miscellaneous property book entry, I then sign as witness. I noted that amongst the property listed, there were a set of eight keys, as usual procedure I would have returned them along with the other property listed.
6. Other then returning the mentioned property, I have no other recollection of any involvement in this matter.
