Summary:

- Para 3.: Statement made on the 25/09/2001 true and correct relating to the disappearance of Ross WARREN.
- Para 4.: But wishes to add further to the statement made on 25/09/2001, that in paragraph five of this statement he stated he did not know the phone number of Redfern. Now believes the phone number was possibly

 Also stated that he does not remember talking to Phillip ROSSINI on the night WARREN disappeared.
- **Para 5.:** That on the 02/08/2001, freely participated in a electronically recorded interview (on video) with Detective DAGG regarding the disappearance of Ross WARREN.
- Para 6.: That during the interview he indicated a location he found WARREN's car. This being outside number 25 Kenneth Street Tamarama. That he was also shown a photcopy of a colour photogaph of a brown Nissan Pulsar. That this vehicle was WARREN's and the one he located in July 1989. The car is shown in the photograph as parked in a suburban street, ELLIS states that this is not were he found WARREN's car. Investigators believe that this location may possibly be near the old Bondi Police Station.



- 5. About 11.35am on Thursday the 2nd of August 2001, I returned to the Kenneth Street Tamarama, near to the location were I had located Ross's car in July 1989. I freely participated in a video interview with Detective Senior Constable DAGG. Whilst speaking to Detective DAGG he asked me a number of questions and I answer those questions which I believe was recorded electronically on video tape.
- 6. During the course of the video taped interview I indicated a location near the corner of Kenneth Street and Marks Street Tamarama. This area is near the driveway of a block of units being number 25 Kenneth Street Tamarama. I was also shown a colour photocopy of a photograph depicting a brown Nissan Pulsar. This is definitely Ross WARREN's car which I located in Kenneth Street in July 1989. The only difference I can see in the photograph is the location that is depicted with the car. This is not the location were I found Ross's car. I have signed and marked this photocopy as Annexure A and is attached to this statement.
- 7. During the electronically recorded video interview with Detective DAGG, I was asked a number of questions and I freely answered those questions which I believe were recorded electronically on video tape. This recording is a true and correct to the best of my knowledge.
