On the 18/10/2016 Adine BOHEME, AFP Forensic Biologist informed NSWPOL that after consultation with AFP imaging experts, and viewing the CD and Negatives, it is their opinion the images cannot be enhanced to a level that will enable me to make any further meaningful comparisons.

BOHEME was asked wether or not she could comment on the possibilities the hairs located on RUSSELL's hand belonged to him or those of an unknown person.

On the 30/11/2016 DSC CHEBL and TIERNEY attended the AFP, Majura and met with BOHEME. During this time BOHEME stated she was preparing a statement for NSWPOL relating to a review of various homicides that depict a deceased's hair and offenders hair on the deceased. NSWPOL asked the question of the possibilities the hair on RUSSELL's hand belonged to him or had come from an unknown person.

BOHEME stated she conducted a review of a number of cases from around Australia and found a number of examples where the victim of a homicide (where they sustained injuries to there head) had a bundle of their own displaced hair on or around their body. BOHEME further stated that generally in homicides if a offenders hair is left in the crime scene it would generally be a single strand of hair rather then a bundle. BOHEME also stated its highly probable as RUSSELL had a 7.5cm laceration to the back of his head that the hair from around the wound would be displaced.

BOHEME did concede that a Forensic Pathologist would be in a better position than her to offer opinion on the possibilities of displaced hair being from a deceased within a crime scene.
