**BONDI POLICE SEEK THE PUBLIC'S ASSISTANCE REGARDING
 A DECEASED MALE BODY FOUND UNDER CLIFFS AT SOUTH BONDI.**

About 10.00am on Thursday 23rd November 1989, the deceased body of John Alan RUSSELL 31 years old, a resident of Bondi was found lying fully clothed in a Rock pool below a 12 metre cliff at South Bondi. The area in question is a small Bay south of the Bondi Swimming Baths and Notts avenue. There is a footpath which runs around the Bay along to a Headland Point known as Mackenzies Point. The area where the body was found is below Marks Park and a set of steps which leads up to Fletcher street, South Bondi.

Police enquiries reveal that Mr Russell had been drinking with a friend at the Bondi Hotel up until 11.00pm on wednesday evening the 22nd November 1989. His movements from that time until 10am on Thursday the 23rd November 1989 when the body was found are not known. Any person who may have seen or spoken to Mr Russell during those hours is requested to contact Police.

Any person who was in the vicinity of the footpath surrounding the small Bay just south of Notts avenue and may have seen Mr Russell (photograph attached) is requested to contact Bondi Police Station on 30.7060 or 30.2841. Any information received will be in confidence

Description

Mr Russell is described as being 31 years old, 1.62 cms tall or 5 ft 4" inches tall, slim build, brown hair, wearing faded blue jeans with a horizontal tear across each knee, a Red Sloppy joe which has 3 beer motif patches swen on the front, one on each arm and 3 on the back of the Sloppy joe. Wearing Black Gym boots.

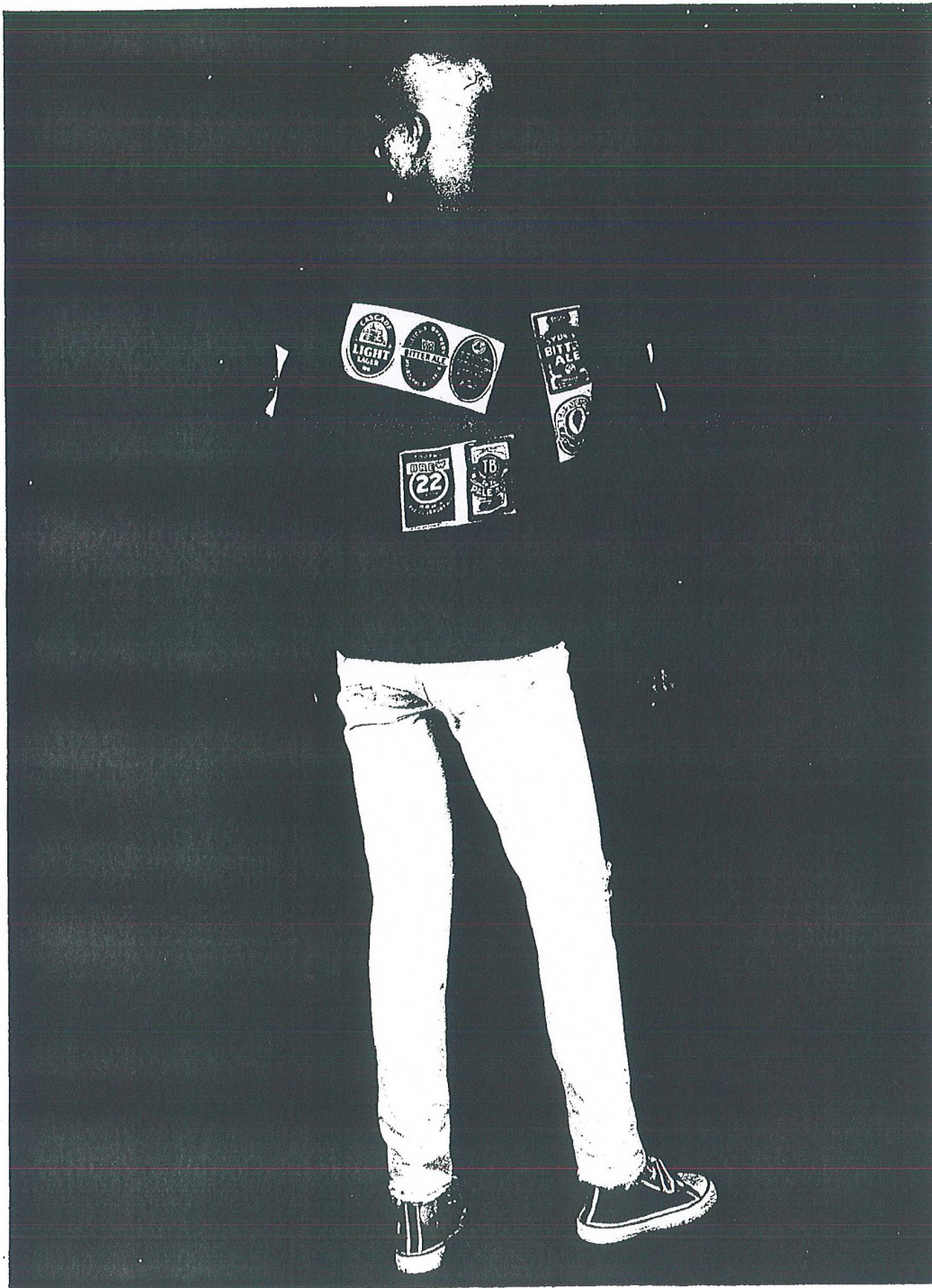

**BONDI POLICE SEEK THE PUBLIC'S ASSISTANCE REGARDING
 A DECEASED MALE BODY FOUND UNDER CLIFFS AT SOUTH BONDI.**

About 10.00am on Thursday 23rd November 1989, the deceased body of John Alan RUSSELL 31 years old, a resident of Bondi was found lying fully clothed in a Rock pool below a 12 metre cliff at South Bondi. The area in question is a small Bay south of the Bondi Swimming Baths and Notts avenue. There is a footpath which runs around the Bay along to a Headland Point known as Mackenzies Point. The area where the body was found is below Marks Park and a set of steps which leads up to Fletcher street, South Bondi.

Police enquiries reveal that Mr Russell had been drinking with a friend at the Bondi Hotel up until 11.00pm on wednesday evening the 22nd November 1989. His movements from that time until 10am on Thursday the 23rd November 1989 when the body was found are not known. Any person who may have seen or spoken to Mr Russell during those hours is requested to contact Police.

Any person who was in the vicinity of the footpath surrounding the small Bay just south of Notts avenue and may have seen Mr Russell (photograph attached) is requested to contact Bondi Police Station on 30.7060 or 30.2841. Any information received will be in confidence

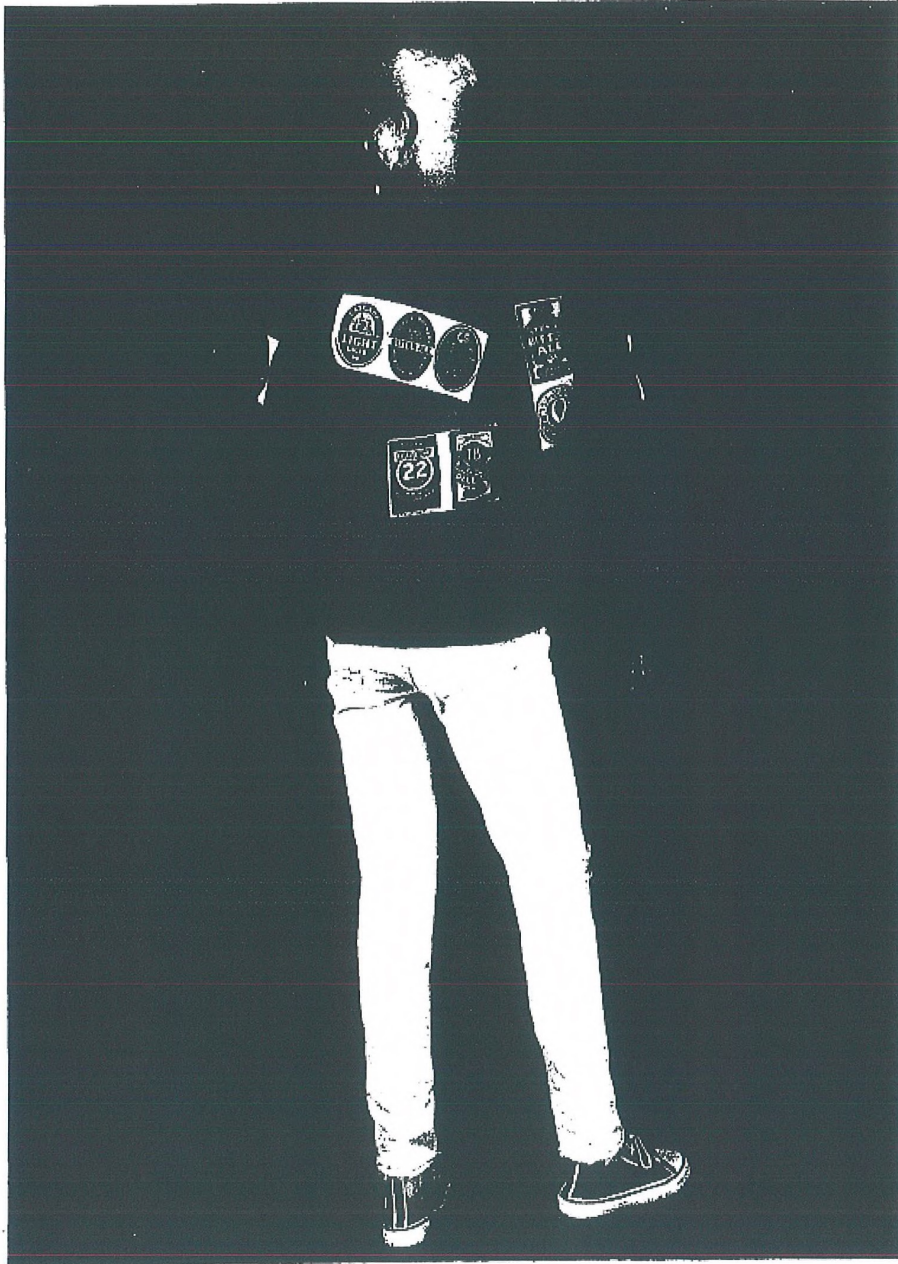
Description

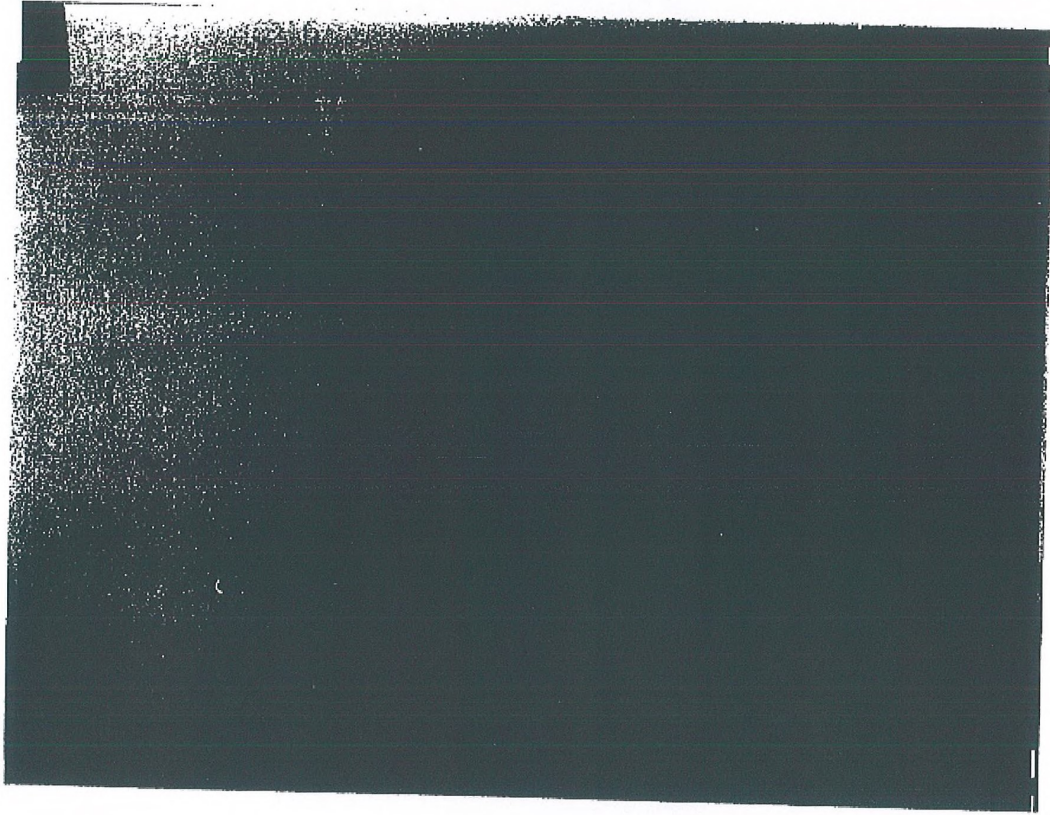
