On 24/11/1989 the body of John RUSSELL was found at the bottom off cliffs at Tamarama. The clothing he was wearing at the time was preserved by his family.

On 14/06/2001, Edwin RUSSELL handed the clothing over to police at Paddington. Shoes, jeans, jumper and \$4.60 worth of coins were booked up at Paddington Police Station under exhibit book reference 19/C607290.

On 18/06/2001, the exhibits were conveyed to DAL and booked up under reference FS 01/1971 where they were examined.

On 13/04/2016, DSC OLDFIELD spoke to John BIGNELL at FASS. He indicated that FASS records state that the exhibits were "Sent out" and returned on 27/03/2007. An email was forwarded to FASS to obtain further records pertaining to this movement.

On 13/04/2016, DSC OLDFIELD spoke to Sgt Donald BROWNING, Exhibit Officer at Paddington Police Station. A request was emailed to him regarding further searches of exhibit books in an attempt to locate the exhibits.

The exhibits were conveyed to DAL on the 18/06/2001 and returned on the 11/09/2007 (I think writing a bit difficult to read).

They were then booked up with other exhibits under Operation Taradale in the long term Exhibit book on the 02/08/2011 as D685416, items 1,2 and 3.

Exhibits were forwarded to Potts Hill on the 24/01/2013.

On 15/04/2016, DSC CHEBL and DSC OLDFIELD located the clothing at MEPC, Potts Hill. The were resealed and booked up on EFIMS. J01475691 relates.
