It was identified that 18 items were booked up under Operation Taradale in the Long Term Exhibit Book at Paddington on 02/08/2011. D685416 relates.

On 24/01/2013, DSC Grant DAVIDSON from UHT collected these items and conveyed them to MEPC at Potts Hill.

On 15/04/2016, Det Sgt TSE [REDACTED] DSC OLDFIELD [REDACTED] & DSC CHEBL [REDACTED] attended MEPC, Potts Hill and located a sealed box labelled (Suspicious Deaths, Det Stephen PAGE, Operation Taradale. Book 61 D685416. Items 1-18.)
