CRIME SCENE OPERATIONS BRANCH (CSOB) NOTIFICATION AND CALL OUT GUIDELINES

Command Notification Categories - 24 hour basis:-

<u>Category 1:</u> Immediate notification. Crime Scene Investigator to notify Zone Manager of incident. Zone Manager to notify

CSOB Operations Coordinator/Referral Officer.

Category 2: Crime Scene Investigator not required to report incident to Command. (Note:#)

Crime Scene Investigator or Zone Manager to report incident to CSOB by phone followed by SITREP if incident is of High Profile/ Media Interest. (Memo address: #CSOB) SITREP to be forwarded as soon as practicable.

Crime Scene Investigators must assess all jobs against these guidelines. Where, due to the circumstances of the incident, doubt exists regarding the immediate need to respond, contact the Zone Manager or CSOB Referral Officer for advice.

An initial scene assessment, within the first 30 minutes of arrival, must be conducted by the Crime Scene Investigator and a decision should be made as to whether or not the Crime Scene Operations Branch should be contacted through the Zone Manager.

Where advice or consultation is required regarding examination of a crime scene, the local Zone Manager or the Crime Scene Operations Branch Coordinator / Referral Officer can be contacted through the Duty Operations Inspector (DOI).

THE FOLLOWING CRIME/INCIDENT TYPES ARE INTENDED AS A GUIDE ONLY AND INDICATE THE TYPES OF CRIME/INCIDENT SCENES WHICH, POTENTIALLY, NECESSITATE CALL OUT ON A 24 HOUR BASIS:-
