MAJOR / SERIOUS CRIME and INCIDENTS

Events needing IMMEDIATE response to a preserved and guarded scene.

'Crime Scene Examiners' (Fingerprint and Physical Evidence) are experts located at:

- Albury Crime Scene Section Fingerprint and Physical Evidence
- Wagga Wagga Crime Scene Section Fingerprint and Physical Evidence

(The Crime Scene Sections are not part of the LAC or Region.)

After hours re-call to duty

Police at the scene, in consultation with the Duty Officer and Senior Investigator should -

Contact VKG Wagga Wagga for reference to the on-call roster.

VKG Wagga Wagga

- Ring the mobile telephone of the crime scene section.
- Ring the home number of the on-call crime scene examiner.
- Ring the mobile telephone of the crime scene section AGAIN.
- Please be aware that the person may not reach the telephone before it diverts to message bank.
- Ring again immediately.

*** Police Stations do not have the crime scene section rosters ***

Please note:

- Crime Scene Examiners have responsibility to justify their re-call, based on information provided to them and inquiries they make.
- It is not the prerogative of a Duty Officer or Supervisor to direct the re-call of Crime Scene Examiners.
- Disputes should be referred to the Zone Manager, South Western Zone and/or the Crime Scene Operations Branch - On Call Referral Officer.

VOLUME / MINOR CRIME – attended by 'FORENSIC STAFF'

- Scenes and events which are not fully preserved or guarded, or remain directly under Police control
- Require action to preserve portions, or items, of the scene for later examination, such as -
 - Enter & Steal;
 - Stolen Motor Vehicles;
 - Steal from Motor Vehicle;
 - Exhibits collected for any of these offences.

'Forensic staff', either -

- Civilian 'Scene of Crime Officers'
- Crime Scene examiners from each of the three Sections.
- Police 'Scene of Crime Officers' (SOCO) see table.

Requests for forensic examination of minor crime scenes from car crews via VKG -

- VKG to call for the local SOCO vehicle
- Available SOCO will advise an estimated time to attend.
- Immediate response CANNOT be expected due to staff distribution.
- Car crews are to take steps to preserve the locations and items to be examined.
- OIC to return to the station and create a Forensic Job in the Event (required for every scene
 examined by examiners or SOCOs)
- 'Forensic staff' will contact the victim based on information provided in the forensic job request.
- VKG operators should not make multiple searches to locate 'forensic staff' to attend a minor crime scene.
- It is the OIC's responsibility to take appropriate steps to preserve potential evidence and make the request for forensic examination.
