

- 5. When in that room, I said to the defendant, "I am Detective Sergeant PHILLIPS and this is Detective Sergeant SAUNDERS. We are from the Redfern Detectives Office. Is your name Anthony HOOKEY?" He said, "Yes." I said, "I am making enquiries into an assault committed upon a man named Robert MALCOLM at Redfern about the 10th of January 1992. Mr. MALCOLM subsequently died as a result of that assault. It is my intention to ask you further questions in regard to this matter. Do you understand that?" He said, "Yes." I said, "My questions together with your answers will be recorded on the typewriter as the interview takes place. Do you understand that?" He said, "Yes." I said, "At the conclusion of the interview you will be given the opportunity of reading through it and signing it. Do you understand that?" He said, "Yes." I said, "You will also be given a complete copy of the interview." He said, "I can't read or write very well. Can Sergeant MARTLEW sit in with me?" I said, "Alright." I left the room and returned a short time later with Sergeant MARTLEW. I said to the defendant, "As you requested, I've asked Sergeant MARTLEW to sit in on the interview, is that okay with you?" He said, "Yeah, that's okay."
- 6. I then asked the defendant a number of questions.

 Those questions together with the defendant's answers were recorded on the typewriter by Detective Sergeant SAUNDERS as the interview took place. At the conclusion of the interview I said to the defendant," Are you happy to have Sergeant MARTLEW read out to you the record of interview?" He said, "Yeah, I can't read properly. - 7. A short time later we returned to the room where Sergeant MARTLEW said, "I have read out the record of interview and there are two questions that need correction.
- 8. I then asked the defendant a number of additional questions and those questions together with the defendant's answers were recorded on the typewriter by Detective Sergeant SAUNDERS. Sergeant MARTLEW then read those additional questions and answers to the defendant.
- 9. The record of interview was handed to the defendant and he signed each page of it. I also signed each page of the interview as did Sergeant MARTLEW. Sergeant MARTLEW then said to the defendant, "I will now ask Constable TATTERSALL to come into the room and ask you some questions in relation to the record of interview, is that okay with you?" He said, "Yeah." Sergeant MARTLEW left the room and Constable TATTERSALL entered it a short time later. 11.After Constable TATTERSALL left the room Detective Sergeant SAUNDERS and I re-entered it. I said to the defendant, "You will be charged with the murder of Robert MALCOLM at Redfern on the 29th of January 1992. Do you understand that?" He said, "Yes." A short time later, whilst Detective Sergeant SAUNDERS was obtaining relevant personal details from the defendant, he said, "Can't you make it manslaughter?" I said, "No."

- 11. I later accompanied the defendant to the side office of the Police Station and said to Sergeant MARTLEW, "I just told him that he is to be charged with murder. Sergeant MARTLEW said to the defendant, "You are to be charged with murder after which I will make a bail determination." He said, "I hope I can get the charge dropped." Shortly after I left the side office.
- 12. After attending to further records and conferring with Sergeant MARTLEW, Detective Sergeant SAUNDERS and I left the Police Station.
