Sergeant Martlew was also present and he said to the defendant, "These men are Detectives Sergeants Saunders and Phillips from Redfern Police Station. Detective Phillips said, "Can you come into this office with us" He said, "Yeah." The defendant then went with us to another room of the Station.

Detective Phillips then said to the defendant, "I am Detective Sergeant Phillips and this is Detective Sergeant Saunders. We are from the Redfern Detectives Office. Is your name Anthony Hookey?" He said, "Yes."Detective Phillips said, "I am making inquiries into an assault upon a man named Robert Malcolm at Redfern about the 10th January, 1992. Mr. Malcolm subsequently died as a result of that assault. It is my intention to ask you further questions in regard to this matter. Do you understand that?" He said, "Yes." Detective Phillips said, "My questions together with your answers will be recorded on the typewriter as the interview takes place, Do
