- 1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in Court as a witness.
- 2. The statement is true to the best of my knowledge and belief and I make it knowing that if it tendered in evidence, I shall be liable to prosecution if I have wilfully stated in it anything which I know to be false or do not believe to be true.
- 3. I am 28 years of age.
- 4. During the afternoon of Friday, 12 June 1992 I spoke with Mr Chris MAXWELL of the Director of Public Prosecutions. At 2.30pm the same day with Constable 1/C LE JEUNE I attended the Redfern Court.
- 5. At the Court I saw the defendant Richard John GREEN. I said to the defendant outside the Court room, " As you know I'm Detective STARR. This is Constable LE JEUNE. Do you have a Solicitor here? " He said, " Yeah in Court. " I said, " Richard you are under arrest for accessory after the fact to murder, in relation to the death of Robert MALCOLM. You are not obliged to say anything further about this matter unless you wish to do so but whatever you do say will be recorded and it may later be used as evidence. Do you understand that? " He said, " Bloody murder it was an assault. " I said, " I'll get a solicitor for you. Come into Court. " Constable LE JEUNE and I entered the Court with the defendant. I spoke with June ROZEN, Solicitor. Senior Constable MOUBARAK arrived at the Court and the defendant was taken to the foyer outside the Court. In the presence of June ROZEN solicitor I said to the defendant, " You are now going to Redfern Police

Station. Do you understand that?"



He said, "This is my bloody life. " The defendant was taken to the Redfern Police Station and lodged in an interview room within the Detectives office.

- 6. With Constable 1/C LE JEUNE and Senior Constable MOUBARAK I said to the defendant, "Do you wish to take part in an electronic Record of Interview. You are not obliged to take part in an interview unless you wish to do so but whatever interview you make will later be used as evidence. Do you understand that? "He said, "No. "I said, "Do you wish to go on the video to decline the offer of an electronic interview?" He said, "No. I'll see my solicitor. "I said, "Do you wish to make a hand written statement about this matter?" He said, "No. If Kirk has done this to me he's a fucking dog. "I said, "Do you wish to read these notes I have made?" He said, "Yes. "I handed Police notebook number F 82352 to the defendant and he appeared to read the entry.
- 7. I said, "Are they a correct record of our conversation?"
  He said, "Yes." I said, "Do you wish to sign these notes as to their correctly being recorded?" He said, "Yes." I said, "I'll have a Sergeant speak to you." I left the room with the notebook. A short time later I returned to the room and said, "This is Sergeant MARKS." I handed the Police notebook to Sergeant MARKS. With Constable's LE JEUNE and MOUBARAK I left the room.
- 8. A short time later Sergeant left the room and returned the notebook and a one page statement to me. I saw he had signed and dated the notebook entry. I returned to the room and said to the defendant, " You will shortly be going to Court. Do you understand that ? " He said, " Yes. "
- 9. I spoke with Solicitor ROZEN and she entered the room with the defendant. I attended to another matter. I spoke with Solicitor LEISE and she also entered the interview room with the defendant.
- 10. I returned to the interview room and I said in the presence of Solicitor LEISE, " I'll make you a copy of these notes. Will you sign for a copy?" He said, " Yeah. " The defendant then signed for and was
