1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness.

2. The statement is true to the best of my knowledge and belief and I make it knowing that if it is tendered in evidence I shall be liable to prosecution if I have wilfully stated in it anything which I know to be false or do not believe to be true.

3. I am 28 Years of age.

4. On Friday the 12 June, 1992 at 2.30pm I attended Redfern Court with Detective STARR. Whilst at court I saw the defendant Richard John GREEN, Detective STARR approached GREEN and said, "As you know I'm Detective STARR. This is Constable LeJEUNE. Do you have a solicitor here?" He said, "Yeah in Court." STARR said, "Richard, you are under arrest for accesory after the fact to murder, in relation to the death of Robert MALCOLM. You are not obliged to say anything further about this matter unless you wish to do so but whatever you do say will be recorded and may later be used as evidence. Do you understand that?" He said, "Bloody murder it was an assault." I said, "I'll get a solicitor for you. Come into Court."

5. I then entered the Court with STARR and the defendant, SIARR then had a conversation with the defendants solicitor and then went outside the Court foyer. In the presence of the Defendants solicitor, STARR said to the defendant, "You are now going to Redfern Police Station. Do you understand that?"

He said, "This is my bloody life." The defendant was then taken to the Redfern Police Station and placed in a interview room in the Detectives office.

6. Whilst Senior Constable MOUBARAK and myself were in the interview room, STARR said to the Defendant, "Do you wish to take part in an electronic record of interview. You are not obliged to take part in an interview unless you wish to so so but whatever interview you make will later be used as evidence. Do you understand that ?" He said, "No." STARR said, "Do you wish to go on the video to decline the offer of an electronic interview ?" He said "No. I'll see my solicitor." STARR said, "Do you wish to make a handwritten statement about this matter ?" He said, "No. If Kirk has done this to me he's a fucking dog." STARR said, "Do you wish to read these notes I have made ?" He said, "Yes." STARR then handed his notebook to the defendant and he appeared to read the entry.

7. STARR said, "Are they a correct record of our conversation ?" He said, "Yes." STARR said "Do you wish to sign these notes as to their correctly being recorded ?" He said, "Yes." STARR said, "I'll have a Sergeant speak to you." STARR then left the room with MOUBARAK and myself remaining with the defendant. STARR then returned to the room and said to the defendant, "This is Sergeant MARKS." STARR then handed the notebook to MARKS. STARR, MOUBARAK and myself then left the interview room. A short time later MARKS then left the room and returned the notebook and a one page statement to STARR. STARR said to the defendant, "You will shortly be going to court. Do you understand that ?" He said, "Yes."

8. I then attended to other matters whilst STARR and MOUBARAK took the defendant to Redfern Court to be formally charged with the matter now before the court.
