1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in Court as a witness.
2. The statement is true to the best of my knowledge and belief and I made it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated in it anything which I know to be false or do not believe to be true.
- 3 I am 57 years of age.
4. On Friday 10 January, 1992, about 9pm I was at the top of Eveleigh Street and Lawson Street about to cross the crossing. When I saw white fella and he was well dressed which was what caught my attention and he was talking to Beaver.
5. The white fella was helpless drunk and Beaver said to the white fella,  
"Come down here Aunty Kay's down here."  
I know the white fella was drunk because he was unsteady on his feet and his head was down against his chest and he was trying to lift it but he couldn't.

6. I kept walking to the station to catch my train and the last I saw of the white fella he was walking down Eveleigh Street with Beaver who is Pat HOOKEY's son.

7. On Saturday 11 January, 1992, after lunch two <sup>shirt</sup> Detectives and a uniform sergeant came to my place. <sup>looked</sup> <sup>light trousers</sup> They showed me a photograph and I said, "That's Beaver."

8. About 1.20pm today two Detectives came to see me the female being one of the Detectives I spoke to on Saturday. They showed me a photograph of three white males and one white female. The male on the far left of the photo had the same hair and same sort of build as the white fella I saw Beaver with on Friday night. I didn't get to see his face clearly because he had it slumped on his chest that night.

9. I have known Beaver HOOKEY since he was about 5 or 6 but I don't know what his real name is.

10. When I saw Beaver on that Friday night he was wearing a red coloured jumper maybe with a v-neck and track pants. The white fella was wearing light coloured maybe white or cream dressy shirt and light coloured trousers like suit trousers. I thought he would be about 40, solid build, brown hair and that's about all
