About 9pm on Friday 10/1/92 a man of similar description to the victim was seen in the company of Anthony Stanley HOOKEY b. [REDACTED]/71 alias Beaver HOOKEY in the Eveleigh Street, Redfern area. The man(victim) appeared intoxicated and unsteady on his feet. The victim and HOOKEY were seen by several witnesses. About 2.05am on Saturday 11/1/92 the victim was found unconscious in a derelict house situated on the sth/easter corner of Holden and Eveleigh Streets, Redfern by several teenagers (aboriginal). They then informed other members of the aboriginal community and CDA were summoned. The victim was then conveyed to R.P.A. in an unconscious condition where he died about 7.10pm on Wednesday 29/1/92

From the post mortem examination it is believed that the victim was struck about the face with a heavy weapon whilst lying on the ground.

A large number of persons have been interviewed in relation to this murder with very little assistance being given by the aboriginal people of the Eveleigh St area.

HOOKEY was interviewed on 11/1/92 and 13/1/92 by Police and has denied any involvement or that he was in fact in Eveleigh Street at the times mentioned by the 3 witnesses.

Inquiries are continuing.
