RESUME RE: ROBERT HART MALCOLM.

ABOUT 2.15AM ON 11/1/92 THE VICTIM, ROBERT HART MALCOLM, BORN 13/3/50 OF [REDACTED] JANNALLI, WAS FOUND BY KIRK ANTHONY PHILLIPS, RICHARD IAN GILMORE, RICHARD JOHN GREEN, [REDACTED] 1309, [REDACTED] 1308 AND [REDACTED] 1310 (ALL ABORIGINALS) IN A ABANDON BUILDING ON THE CORNER OF EVELEIGH STREET AND HOLDEN STREET AT REDFERN. THE BUILDING IS OWNED BY THE ABORIGINAL HOUSING CO-OP AND IS IN A BAD STATE OF DISREPAIR. THE VICTIM WAS SUFFERING MASSIVE HEAD INJURIES AND WAS PARTLY CLOTHED. BOTH UNDERPANTS AND TROUSERS WERE DOWN AROUND HIS ANKLES AND HIS BODY WAS PROPPED UP WITH A STICK AS TO LAY HIM ON HIS SIDE.

CRIME SCENE ATTENDED (ON TWO OCCASIONS) AND TOOK POSSESSION OF A PIECE OF TIMBER, TWO BEER BOTTLES, A NEWSPAPER, THE VICTIMS CLOTHING AND OTHER ITEMS. (CRIME SCENE POLICE - VAN LEWYN AND RAYMOND).

THE VICTIM WAS CARRYING NO IDENTIFICATION ON HIM OR ANY OTHER ITEMS AND HE WAS IDENTIFIED BY HIS FATHER, ROBERT MCPHERSON MALCOLM, ON 13/1/92. AT THIS TIME THE VICTIMS CONDITION IS STILL SERIOUS WITH EXTENSIVE BRAIN DAMAGE AND IS STILL IN A STATE OF UNCONSCIOUSNESS.

ACTION: CANVASS CARRIED OUT BY DETECTIVES AND UNIFORM POLICE OF EVELEIGH STREET AND SURROUNDING AREA, STATEMENTS OBTAINED FROM WITNESSES BY DETECTIVES YANNAKIS, THOMAS, PC CONSTABLES BULLOCK, HARDY AND MORLAND. DETECTIVE SERGEANT LISLE AND DET. SEN. CON. EMMETT FROM HOMICIDE WERE NOTIFIED AND IN ATTENDANCE AND ASSISTED.

AT THIS TIME IT WOULD APPEAR THAT WE HAVE A SUSPECT, ANTHONY "BEAVER" HOOKEY OF [REDACTED] WATERLOO ([REDACTED]) - WELL KNOWN TO POLICE FOR OFFENCES AGAINST PERSON AND PROPERTY, WHO WAS SEEN BY WITNESS - MERL ROBERTS AT THE TOP END OF EVELEIGH STREET ABOUT 9PM ON FRIDAY 10/1/92 AT THE TIME THEY WERE OBSERVED WALKING NORTH IN EVELEIGH STREET IN THE MIDDLE OF THE ROAD WITH A MALE CAUCASION MATCHING THE VICTIMS DESCRIPTION. BOTH APPEARED TO BE INTOXICATED AT THIS TIME. THIS HAS BEEN SUBSTANTIATED BY OTHER PERSONS WHO ARE NOT PREPARED TO BECOME INVOLVED OR GIVE STATEMENTS.

THE SUSPECT WAS INTERVIEWED BY DET. SGT. LISLE AND EMMETT ON 11/1/92 WHERE HE DENIED ANY KNOWLEDGE OF THE WHOLE INCIDENT. BRIEFLY, HE INFORMED POLICE THAT HE WAS DRINKING AT THE CLIFTON (WATERLOO TAVERN) AND LATER WENT TO THE MANSIONS HOTEL AT KINGS CROSS WITH A NUMBER OF PEOPLE AND LATER WENT FOR A WALK AROUND THE CROSS AND WENT TO THE TOILET AND THEN TO THE SUBWAY HOTEL. HOOKEY AGAIN WAS INTERVIEWED BY DET. SGT. LISLE AND EMMETT ON 13/1/92 AND A STATEMENT WAS OBTAINED FROM HIM AS TO HIS MOVEMENTS ON THAT PARTICULAR EVENING.

THE BOTTLE MENTIONED ABOVE, LOCATED AT THE SCENE, HAS BEEN FINGERPRINTED AND HOOKEY'S FINGERPRINTS WERE NOT FOUND ON SAME, HOWEVER A NUMBER OF PRINTS HAVE BEEN LOCATED ON THE BOTTLE AND INQUIRIES ARE CONTINUING RE: SAME BY FINGERPRINTS. THE BOTTLE ITSELF IS A LARGE "STUBBY" WHICH AT THE TIME WAS FULL OF BEER AND APPEARED TO BE FRESH.

IT HAS BEEN ESTABLISHED THAT THE VICTIM COMMENCED DRINKING AT THE MENZIES HOTEL ON THE FIDAY EVENING AND A NUMBER OF STAFF HAVE BEEN INTERVIEWED AND AT THIS TIME THERE IS SOME DISCREPANCIES AS TO WHAT TIME HE LEFT, POSSIBLY AS LATE AS 10.00PM. INQUIRIES CONTINUING.

A NUMBER OF THE VICTIMS WORKMATES HAVE BEEN INTERVIEWED AT THE G.P.O., SYDNEY, WHERE HE EMPLOYED AS A SALARIES CLERK. IT HAS BEEN ESTABLISHED THROUGH THEM THAT THE VICTIM HAS A DRINKING PROBLEM AND IS KNOWN TO FREQUENT HOTELS IN THE CITY AND SURROUNDING AREAS FREQUENTED BY ABORIGINALS.
